Accounting Department Update.

Beghin highlighted departmental activities and efforts in compiling a Comprehensive Annual Financial Report (CAFR) and responding to a 2011 single audit finding. **Motion by Wenzel, second by Lombard to approve payment of Accounting Department invoices in the amount of \$912.00 and County invoices in the amount of \$2,123,601.20. Motion carried.**
