Wisconsin State Statues require all counties to provide services, programming and products under five (5) major divisions of county government. Below are the areas of expertise and what defines each division.



General Government:

This division combines 12 areas of expertise including accounting; administration; building services; corporation counsel; county clerk and elections; justice, diversion and support; land records modernization; management information systems; personnel; register of deeds; surveyor and county treasurer.

Public Works & Transportation:

This division is a versatile group of talented individuals responsible for highway maintenance, road conditions, Great Sauk State Trail construction and more. In 2024, two new shops, Baraboo and Reedsburg, will provide a safer working environment.

Justice & Public Safety:

The Justice and Public Safety division is one of the county's largest divisions comprised of circuit courts; clerk of courts; coroner; court commissioner, family court counseling; district attorney and victim witness; emergency management; register in probate and the sheriff's department.

Total FTE Employees: 174.94








