1. Petition 04-2021. A petition from Dana and Logan Sechler / Lo Bar Ranch LLC, to consider a conditional use permit for an Stable and Equine Facility, pursuant to s. 7.027(12) and a conditional use permit for a Resort, pursuant to s. 7.036(6) on land owned by Dana and Logan Sechler.
