# AUTHORIZING THE CREATION OF ONE FULL TIME HEALTH EDUCATOR POSITION AND ELIMINATING ONE FULL TIME PUBLIC HEALTH NURSE POSITION

Background: Creating one full time Health Educator position for the Sauk County Health Department outside the budget process for the WI-PDO grant. A Health Educator educational background includes health assessments, environmental scans, data analysis and coalition building. With the initial request the department was going to use a nurse to provide education and dispense Naloxone at public meetings however, in review of the nurse practice act and state statutes, nurses are unable to dispense prescription medication. A Public Health Nurse costs approximately \$93,466 annually whereas a Health Educator costs approximately \$82,976 a difference of \$10,424.

WHEREAS, "a local health officer shall administer all funds received by the local health department for public health programs" as established by Wis. Stats. \$251.06(d); and,

WHEREAS, "a county board shall appropriate funds for the operation of a health department and the local board of health shall annually prepare a budget ...." as established in Wis. Stats. \$251.10; and,

WHEREAS, the Sauk County Board of Supervisors approved the Prescription Drug/Opioid Overdose Related Deaths (WI-PDO) Grant to train and distribute Naloxone in the community with the 2016 budget and funding exists for the next five years; and,

WHEREAS, A Health Educator's role is to provide education and coalition building funded through the WI-PDO grant that will allow first responders (law enforcement, fire and rescue, and crisis workers) and family members the opportunity for Naloxone administration training and distribution; and,

WHEREAS, the goal of the WI-PDO grant is to decrease the number of opioid overdose related deaths and adverse events by 10% among individuals 18 years and older, In 2015, there were 12 deaths, in 2016 there were 14 deaths and in 2017 there are potentially 5 deaths year to date in Sauk County from Opioid overdose; and,

WHEREAS, the first date of Naloxone training and education will be June 27, 2017 and will be provided to county employees that may be exposed to heroin in the course of their job duties and consecutive trainings to the community at large will be scheduled throughout the grant cycle; and,

WHEREAS, a Health Educator is trained in these processes along with education on grant writing, data collection and analysis; and,

WHEREAS, in order to comply with the WI-PDO grant requirements the Health Director, Deputy Director have evaluated the program requirements and how best to meet the goals and objectives; and,

WHEREAS, the Board of Health has endorsed the creation of the Health Educator position to carry out the required functions as established; and,11

With the initial request the department was going to use a nurse to provide education and dispense Naloxone at public meetings however, in review of the nurse practice act and state statutes, nurses are unable to dispense prescription medication, a nursing position isn't required; and,

WHEREAS, it would be in the best interest of the County to create one full time Health Educator position for the Health department outside the budget process; and,

**NOW, THEREFORE, BE IT RESOLVED,** by the Sauk County Board of Supervisors, met in regular session, that a full time Health Educator position be created and one full time Public Health Nurse position be eliminated effective June 20, 2017.

## ORDINANCE NO. <u>5</u>-2017

# PETITION 12-2017. APPROVING THE REZONING OF LANDS IN THE TOWN OF PRAIRIE DU SAC FROM AN EXCLUSIVE AGRICULTURE TO AN AGRICULTURE ZONING DISTRICT FILED UPON ELSING FARMS, PROPERTY OWNERS.

WHEREAS, a public hearing was held by the Conservation, Planning, and Zoning Committee upon petition 12-2017 as filed by Elsing Farms, property owners, for a change in the zoning of certain lands from an Exclusive Agriculture to an Agriculture Zoning District; and

WHEREAS, the purpose of the request is to obtain a special exemption permit pursuant to s7.030 non-metallic mining site, one acre or greater, to operate a sand pit; and

WHEREAS, the Town of Prairie du Sac Town Board has approved the rezone request; and

WHEREAS, the Conservation, Planning, and Zoning Committee reviewed and discussed the request as described in petition 12-2017; and

WHEREAS, the Conservation, Planning, and Zoning Committee, based upon the facts of the request and public testimony heard at the public hearing on May 23, 2017, recommended to the Sauk County Board of Supervisors that the petition be approved.

## **ORDINANCE NO.** \_\_\_ - 2017

# AMENDING CHAPTER 17 OF THE SAUK COUNTY CODE OF ORDINANCES PERTAINING TO HIGHWAY DEPARTMENT PURCHASING AND COMMISSIONER TERMS

Background: For the construction and maintenance of highways, including the removal and control of snow and ice, it becomes necessary from time to time to purchase equipment, the nature and necessity for which cannot be accurately anticipated. Sauk County Financial Policy 4-94 states that bids/proposals are required to be submitted for equipment purchases in excess of \$10,000 with an exception to this requirement for the Highway Department, whose limit is \$30,000 before County Board action is required. Given the need to replace many various pieces of equipment annually in order to maintain a safe, reliable, and cost effective fleet and the fact that equipment costs have increased substantially over past years, this amendment will set the Highway Department's equipment purchasing threshold requiring no County Board action be required for a single unit of equipment costing \$50,000 or less. After the previous Highway Commissioner had been in his role for almost five, two-year terms, the County Board amended the ordinance to allow for an indefinite term. Wis. Stat. § 83.01 provides "(2) Term. (a) Unless the county board establishes a different term of service by ordinance, the county highway commissioner shall serve for a term of 2 years, except as provided in par.(b). (b) Unless the county board establishes a different term of service under par. (a), upon his or her first election or appointment the county highway commissioner shall serve until the first Monday in January of the 2nd year succeeding the year of the election or appointment." This ordinance amends the indefinite term and returns the term to the statutory term.

WHEREAS, this ordinance is adopted pursuant to Wis. Stat. §§ 83.01 and 83.015, to regulate the procedure and methods used by Sauk County for purchasing road machinery and equipment, as well as specifying the election or appointment of the Sauk County Highway Commissioner; and,

WHEREAS, whenever the Sauk County Highway Committee believes that the purchase of any road machinery or equipment shall exceed \$50,000, the purchase of such machinery or equipment shall be made by first advertising for sealed bids on the same at least twice in the official county newspaper; and,

WHEREAS, no road machinery or equipment shall be purchased by the Sauk County Highway Committee, the cost of which shall exceed \$50,000, without the concurrence and permission of the Sauk County Board of Supervisors; and,

WHEREAS, whenever the Sauk County Highway Committee shall advertise for bids pursuant to this ordinance, the Committee, in their advertisement for bids, shall expressly reserve the right to reject any or all bids; and,

WHEREAS, at the annual meeting of the Sauk County Board of Supervisors in odd numbered years, the Sauk County Highway Committee and Administrative Coordinator shall present to the County Board the name of one person they certify as qualified for the position of Highway Commissioner for Sauk County, unless the incumbent Highway Commissioner seeks, and is recommended for reelection. If confirmed by majority vote of the County Board, the person so selected shall serve a two-year term as Highway Commissioner for Sauk County, commencing on the first day of January following said election, unless said election be to fill a vacancy in an unexpired term, in which case the term shall be for the remainder of the unexpired term.

**NOW, THEREFORE, BE IT ORDAINED,** by the Sauk County Board of Supervisors, met in regular session, that Sauk Co. Code ch. 17 is hereby amended to read as provided on the attached Addendum to be effective on June 21, 2017.

17.001 Authority for creation. Pursuant to Wis. Stat. § 83.015, this ordinance is for the purpose of regulating the procedure and methods used by the Sauk County Highway Committee in the purchase of road machinery, equipment, materials and supplies.

17.002 Advertisement for bids. Whenever the Sauk County Highway Committee contemplate the purchase of any road machinery or equipment, where the estimated cost of such machinery or equipment shall exceed \$2,500.00 \$50,000, the purchase of such machinery or equipment shall be made by first advertising for sealed bids on the same, at least twice in the official county newspaper and if deemed necessary by the Sauk County Highway Committee, in whatever other publication the committee feels the interest of the county may demand, , in conformity with the statutory requirements of Wis. Stat. § 66.29. The Sauk County Highway Committee, after receiving such bids, shall award the purchasing contract to the lowest responsible bidder, provided always that the Sauk County Highway Committee may refuse to purchase any item regardless of whether or not it constitutes the lowest bid when they have reason to believe such item is not suitable for the use for which it is intended.

17.003 Approval by the Sauk County Board of Supervisors. No road machinery or equipment shall be purchased by the Sauk County Highway Committee the cost of which shall exceed \$15,000.00 \$50,000.00 without the concurrence and permission of the Sauk County

Board of Supervisors. (1) Whenever such purchase in excess of \$15,000.00 \$50,000.00 is contemplated, the Sauk County Highway Committee shall follow the procedure set forth in s. 17.002, but before awarding the contract for purchase, shall submit the same together with their recommendation to the Sauk County Board of Supervisors to be approved or disapproved by the board.

(2) The date for the receipt and opening of bids shall be so controlled by the Sauk County Highway Committee, that it will be set at such date as will be convenient to the next scheduled meeting of the Sauk County Board of Supervisors.

17.004 Rejection of bids. Whenever the Sauk County Highway Committee shall advertise for bids pursuant to this ordinance, the Committee, in their advertisement for bids, shall expressly reserve the right to reject any or all bids. In the event the estimated cost of such purchase shall exceed \$15,000.00 \$50,000.00 there shall be added "the acceptance of all bids are subject to the approval of the majority of the County Board of Supervisors for Sauk County."

17.005 Purchase of used machinery or equipment. Whenever the Sauk County Highway Committee contemplates the purchase of used road building machinery or equipment, no such item costing in excess of \$5,000.00 shall be purchased without the approval of the majority of Sauk County Board of Supervisors.

17.006 Purchase of materials and supplies. Whenever purchases of materials or supplies, replacement parts for machinery specifically excluded, shall be contemplated by the Sauk County Highway Committee, the cost of which shall exceed \$2,500.00, such materials and supplies shall be purchased on a bid basis.

17.007 Persons notified for bids. Whenever any purchase of road machinery or equipment is to be made by the Sauk County Highway Committee, the estimated cost of which will exceed \$2,500.00 \$50,000, the Sauk County Highway Committee shall give written notice of the date of opening of bids, and the date of the meeting of the Sauk County Highway Committee to consider such bids, to the Chair of the Sauk County Board of Supervisors and Chair of the Finance Committee of the Sauk County Board of Supervisors in order that they may attend such meetings.

17.008 Highway commissioner. In the event of a vacancy in the position of Highway Commissioner, At the annual meeting of the Sauk County Board of Supervisors in odd numbered years, the Sauk County Highway Committee and Administrative Coordinator shall present to the county board the name of one person they certify as qualified for the position of highway commissioner for Sauk County. Such person shall be recruited and screened by the Sauk County Highway Committee and Administrative Coordinator, acting jointly, in accordance with the general hiring procedures established under the county's personnel ordinance, unless the incumbent highway commissioner seeks, and is recommended for reelection. If confirmed by majority vote of the county board, the person so selected shall serve an indefinite a 2-year term as highway commissioner for Sauk County, commencing on the first day of the month January following said election, unless said election be to fill a vacancy in an unexpired term, in which case the term shall be for the remainder of the unexpired term. . The Highway Commissioner may be removed by the County Board in accordance with Wis. Stat. § 17.10920. The county board may, in its discretion, approve an employment agreement for the highway commissioner in accordance with s. 13.03 Sauk County Code.

- 5. Provide preliminary engineering design services and structural engineering services limited to evaluating existing roofs. Hoffman will not provide final engineering design as these services and installation will be provided in the follow-up solicitations for solar and energy efficiency installation contractors.
- 6. Coordinate with serving electrical utilities to determine the acceptability of the solar systems.
- 7. Report the potential for legal issues with respect to solar installations under Wisconsin's regulatory framework to the extent Hoffman is aware of such issues. (Note: Hoffman is not licensed to provide legal advice. Legal review will be the responsibility of SaukCounty. However, Hoffman shall not knowingly recommend a project for which it is common knowledge in the industry that such an installation is unlawful in the State of Wisconsin)

#### Phase 2:

- 1. Develop solicitation documents for solar systems and energy efficiency projects. Collect and evaluate bids; make recommendation to Sauk County. Oversee project installation.
- 2. Act as a representative of Sauk County to oversee construction; design and construction contracts will be held by Sauk County.
- 3. Verify compliance with State of Wisconsin statutes and regulations regarding bidding as well as compliance with County Financial Policies. Hoffman will inform Sauk County of any observed non-compliance by construction contractors retained by Sauk County; contractors remain responsible for compliance with all state and county requirements.
- 4. Review performance in the first and second months of operation and after one year and report to Sauk County on the results of the performance and comparisons to energy efficiency savings and power generation estimates.
