AUTHORIZING TO CONTRACT WITH EAGLE POINT ENERGY FOR THE INSTALLATION OF SOLAR ARRAYS AND THIRD-PARTY FINANCING AT THE HEALTH CARE CENTER AND LAW ENFORCEMENT CENTER FACILITIES

Background: Sauk County has endeavored to conserve energy and be wise stewards of natural resources in all aspects of Sauk County operations, and solar energy is a positive step toward sustainability. Phase I of the original Solar and Energy Efficiency scope of work with Hoffman Planning, Design & Construction Inc. (Hoffman) is complete. Hoffman identified two Sauk County sites, the Health Care Center and Law Enforcement Center, for implementing PV (photovoltaic) systems. Phase II of the scope of work with Hoffman was approved and included solicitation of proposals for PV systems installation and third-party financing at the two sites. In response to Sauk County's Request for Proposal (RFP), Sauk County received a qualified and financially sound proposal for both sites. The next step is to enter into a contract with the proposing firm. The anticipated cost savings for the solar PV systems are in excess of \$550,000.00 over a 25-year period per the terms of the proposal. The proposal provides a highly flexible buy-out arrangement where Sauk County may choose to buy-out the solar PV systems at any year after year 7 through year 25, and has the option not to buy-out the solar PV systems.

WHEREAS, Hoffman Planning, Design & Construction Inc. has assisted Sauk County in obtaining solar PV system grants of \$131,301; and a high quality proposal has been received under Phase II of the Solar and Energy Efficiency Scope of Work from Eagle Point Energy (EPE) for the installation of the solar PV systems and third-party financing of the PV systems that is cash flow positive in year 1 at the Health Care Center (HCC) at \$11,234 and at the Law Enforcement Center (LEC) at \$3,724,

NOW, THEREFORE, BE IT RESOLVED, by the Sauk County Board of Supervisors, met in regular session, that the County Clerk is authorized to sign, on behalf of Sauk County, the necessary agreements to enter into a contractual relationship with Eagle Point Energy (EPE) to perform the work specified in the EPE proposal in response to Sauk County's RFP under Phase II of the Solar and Energy Efficiency Scope of Work; and,

BE IT FURTHER RESOLVED, that the Building Services Facility Director and Corporation Counsel, on behalf of Sauk County, shall negotiate the necessary contracts that shall be lawful and in the best interest of Sauk County, and if an acceptable contract cannot be negotiated, a report shall be made to the Property & Insurance Committee with further consideration by the County Board if necessary.

RESOLUTION TO CONDUCT COUNTYWIDE ADVISORY REFERENDUM ON CREATION OF NONPARTISAN PROCEDURE FOR THE PREPARATION OF LEGISLATIVE AND CONGRESSIONAL REDISTRICTING PLANS

Background: The Sauk County Board of Supervisors passed Resolution No. 86-2017 on September 19, 2017, urging the creation of a nonpartisan procedure for the preparation of legislative and congressional redistricting plans. Historically, legislative and congressional plans in Wisconsin have been subject to partisan influence that puts the desires of politicians ahead of the electoral prerogative of the people. Redistricting that achieves partisan gains is improper. In order to determine whether the people of Sauk County support the creation of a nonpartisan procedure for the preparation of legislative and congressional redistricting plans, the County Board may conduct a countywide advisory referendum, pursuant to Wis. Stat. 59.52(25), in the Spring Election on April 3, 2018.

The question will appear on the ballot as follows:

Should the Wisconsin legislature create a nonpartisan procedure for the preparation of legislative and congressional redistricting plans?

EXPLANATION

The procedure currently used allows the legislature of the majority party to prepare legislative and congressional redistricting plans. This has the potential to result in improper partisan results, allowing legislators to pick their voters, rather than voters pick their representatives, which is what is commonly referred to as "gerrymandering."

A "yes" vote indicates you agree with creating a nonpartisan procedure for preparing redistricting plans to end gerrymandering.

A "no" vote indicates you disagree with creating a nonpartisan procedure for preparing redistricting plans to end gerrymandering.

AUTHORIZING TO JOIN THE WOODLAND ENHANCED HEALTH SERVICES COMMISSION

Background: The Sauk County Department of Human Services has evaluated use of the Clark County Rehabilitation and Living Center (CCRLC) for placement of qualified consumers. This facility has 172 beds and is located in Owen, Wisconsin. The facility offers short-term rehabilitation and/or extended stays with special care services for individuals with dementia or who require skilled nursing (services are offered to create customized care to meet unique and challenging individual needs). It is anticipated that the need for this type of specialized care within Sauk County will steadily increase as the population continues to age and the propitiate rate of Alzheimer's and dementia rise. The facility is Medicare and Medicaid certified and includes services such as respite care, physical therapy, occupational therapy, speech therapy and psychiatric services. To expand and maintain the special services of the CCRLC a collaboration of various counties throughout the state of Wisconsin was formed, the Woodland Enhanced Health Services Commission (WEHSC) under authority of Wis. Stat. §66.0301. Sauk County Department of Human Services is requesting to join the WEHSC and apply for membership (see Associate Member Agreement and Amended and Restated Intergovernmental Cooperation Agreement Creating Woodland Enhanced Health Services Commission). Sauk County Department of Human Services will fund a onetime fee of \$5,000. Commission members have priority access to services at Clark County Rehabilitation & Living Center. WEHSC is governed by representatives from member counties with each member county having a representative on the Board.

About the Commission:

The Woodland Enhanced Health Services Commission (WEHSC) is a collaboration of various counties throughout the state of Wisconsin to maintain and expand on the special services of Clark County Rehabilitation & Living Center. It is a Commission created by an intergovernmental agreement under Wis. Stat. §66.0301 consisting of member counties that hold the license for operating the Nursing Home and Facility for the Developmentally Disabled (FDD) portion of the Clark County Rehabilitation & Living Center. The Commission is contracted with Clark County to provide the infrastructure and staffing for Commission activities related to the Nursing Home and FDD. The State has recognized and accepted this type of "commission ownership" model as set forth in Wis. Stat. §49.49(7). WEHSC was formed in January 2012 and is currently made up of sixteen counties. Member counties include: Barron, Bayfield, Buffalo, Chippewa, Clark, Douglas, Eau Claire, Florence, Jackson, Oneida, Pepin, Polk, Portage, Price, Rock, Rusk, Taylor, Walworth, Waushara, Wood, and Trempealeau.

We will also be replacing two unmarked squads and one prisoner transport van; again the squads being replaced have high mileage. Kayser Ford of Madison had the lowest bid for the nine police specification squad cars and the one 2018 Ford Explorer. Kayser Chrysler of Sauk City had the lowest for the 2018 Dodge Caravan. Koenecke Ford of Reedsburg had the lowest bid for the 2018 Ford F150.
