## AUTHORIZATION TO PURCHASE ONE TRACTOR, 4X4, 31 PTO HP, CAB, AND SPECIFIED ATTACHMENTS FOR THE HEALTH CARE CENTER

Background: The Health Care Center sits on 55 acres of land that needs routine grounds maintenance such as snow removal, mowing, sweeping, brush removal, etc. Current pieces of equipment have outlived their useful life. The primary snow blower / broom unit was purchased in 1998 and is currently non-functional due to transmission issues. Mower unit was purchased in 2003 and needs several repairs. The Sauk County Health Care Center has grounds equipment that was old and in much need of repair and/or replacement. The Health Care Center presented plan for replacements in 2019 Budget and this was approved by the Capital Improvement Projects Committee and then full county board in November with passing of 2019 Budget. A total of \$38,000 was budgeted for use for replacement in 2019 budget. While both bids came in higher than anticipated, the Health Care Center also underestimated the sale of old equipment. We anticipate being able to receive close to \$14,450 for sale of old equipment versus the \$3,500 approved in 2019 budget. This will make up for the increased pricing noted in bids.
