<u>Discussion and possible action on Resolution in Opposition to the Proposed Mitigation Bank Located East of the Tri-County Regional Airport.</u> Sorenson appeared and stated that the ditch was the best thing for the area. Polivka explained the need for the resolution and background behind the project and explained that the main focus is how the project affects the airport. Krueger spoke of Richland and Iowa Counties developing similar resolutions. Motion by E. Peterson/C. Lehman to adopt the resolution in opposition to the proposed mitigation bank located east of the Tri-County Regional Airport. Motion carried, all in favor.
