

ADDENDUM TO FOOD SERVICE AGREEMENT  
DATED OCTOBER 5th, 2020

THIS AGREEMENT is entered into this 15th day of May 2022 by and between Sauk County, West Square Building, 505 Broadway, Baraboo, WI 53913 (hereinafter referred to as "Client") and Consolidated Correctional Foodservice, a division of Consolidated Management Company, 2670 106th Street, Suite 140, Des Moines, IA 50322, (hereinafter referred to as "Consolidated").

WHEREAS, Consolidated operates the food service for the Sauk County Jail facility located at 1300 Lange Court, Baraboo, WI 53913 (the "Facility"); and

WHEREAS, Client wishes to retain Consolidated to provide senior meal food service for ADRC of Eagle Country Sauk County- Baraboo Office, and Consolidated is willing to undertake such responsibilities, on the terms and subject to the conditions set forth herein.

• Consolidated will provide approximately 145 hot lunch meals Monday-Friday (exact meal count to be provided by ADRC staff), except for County recognized holidays and days when the Baraboo School District is closed due to inclement weather. Client will notify Consolidated no later than 7AM if the School District is closed for inclement weather.

- Consolidated will invoice the Client \$5.00 per meal on a weekly basis. Client shall pay Consolidated within fifteen (15) days after receipt of the monthly statement.
- Client will provide a worker to help prepping the meals on Tuesday, Wednesday and Thursday from 7 a.m. – 3:30 p.m. at no cost to the Consolidated.
- The senior meal provided is the same meal as prepared for trustees at the Facility. Should senior meal requirements necessitate a change from the trustee meals Client and Consolidated shall create and agree upon a new menu.
- The senior meals are prepared and served in bulk in Client's supplied warming trays and carts separated for delivery by four locations.
- Client will pick up the meals at 0930 daily and transport meals from the Facility to the delivery locations
- Client will return the warming trays and carts to the Facility by end of day

The initial term of this Agreement (the "Initial Term") shall begin on May 28, 2022 and shall continue until December 31, 2022. It may be terminated by notice in writing given by either party hereto to the other, at least 30 days prior to the date of termination.

IN WITNESS THEREOF, the parties hereto have executed this agreement as of May \_\_\_\_, 2022.

All other Conditions of the Food Service Agreement dated October 5<sup>th</sup>, 2020 shall remain unchanged.
