- NG911 GIS & 911 Data Assessment

This is provided as a one-time service and delivers a comprehensive analysis of the GIS Authority's existing GIS and 9-1-1 data (MSAG and ALI) and a report detailing GIS data readiness in preparation for migration to NG9-1-1. Intrado will perform an in-depth analysis on the GIS data layers required to implement NG9-1-1. This analysis is followed by detailed reports of Intrado's findings and recommendations for the steps needed to achieve full i3 GIS data readiness.

Intrado will perform the data analysis and assessment, develop detailed reports of findings, and communicate these findings and recommendations to end customer.

After Intrado presents the report findings and recommendations, Intrado will use the results to provide GIS data error correction, ALI to GIS data synchronization and other work required to ensure the GIS data is compliant with NG911 GIS data standards, as is described directly below.

- NG911 GIS Data Readiness Services

The goal of this service is to alter existing GIS data layers provided by Sauk County so that they adhere to NENA NG911 GIS data standards and remove as many errors as possible that could potentially cause i3 geospatial routing issues.

Using the results from the NG911 GIS & 911 Data Assessment reporting, Intrado will correct as many GIS data errors as possible using subject matter expertise and specialized tools and proprietary processes. Participation from Sauk County are is required to answer specific questions and to provide local-knowledge feedback that Intrado can use to apply changes to the GIS data. The goal of this service is for the existing GIS data to be critical-error free when performing Intrado Spatial Interface data validations. It is important to note the Intrado Spatial Interface is used to ingress Sauk County GIS data into the AT&T ESInet.

After the GIS data is critical-error free, Intrado will perform another ALI to GIS comparison analysis to identify any discrepancies that need to be investigated and resolved and assist Sauk County with achieving the desired match rate between the GIS and ALI of at least 98%.

- NG911 GIS Onboarding:

NG9-1-1 GIS Onboarding services are a standalone service that deliver the essential services, training, and support needed to successfully deploy NG9-1-1 GIS data within the AT&T ESInet. The AT&T ESInet utilizes Intrado's Spatial Interface and the goal of this service is to ensure the NG911 compliant GIS data can smoothly provision to the ESInet in an ongoing basis.

Intrado will provide web-based training and assist with the initial GIS data load. NG9-1-1 GIS onboarding services establish communication between the end customer, Intrado, and the NG9-1-1 service provider throughout the GIS onboarding phase.

NG9-1-1 GIS onboarding includes Spatial Interface setup and the following services:

- Assignment of an i3 GIS coach
