Project Description:	<p>SpecPro Professional Services, LLC (SpecPro) is under contract with the US Army Environmental Command (Army) to install three (3) monitoring wells for monitoring groundwater contamination that has migrated from the Badger Army Ammunition Plant (Badger AAP). SpecPro has hired Cascade Drilling (licensed driller in Wisconsin) to install the monitoring wells to approximate depths of 119, 165 and 213 feet with an all-terrain vehicle (ATV) roto sonic drill rig with rubber tracks. The three wells will be approximately 15 feet from the edge of the trail, completed above ground with steel locked casings and steel protector posts. Each well will be surrounded by a 2 x 2 foot concrete pad. No chemicals will be used to install the wells. All soil cuttings and trash will be removed from the work zone. The application contains additional information about the equipment and vehicles that will be used.</p> <p>After well installation, development and survey, dedicated groundwater sampling pumps will be installed in each new monitoring well. The new monitoring wells will be part of the Badger AAP groundwater sampling program. Semi-annual groundwater samples (April and September) will be laboratory analyzed for the six isomers of dinitrotoluene (DNT) and volatile organic compounds (VOCs).</p>

Terms and Conditions of Work to be Performed:			
1.	Applicant shall coordinate with Sauk County each day of work to assist with access to the project location.		
2.	Applicant or their authorized agent may enter WisDOT property for the activities described in the attached permit submittal within the above-named project limits.		
3.	Applicant shall adhere to plans submitted to WisDOT (attached).		
4.	Applicant needs to allow trail users to always have the right of way.		
5.	Application shall perform all work in accordance with any state or local ordinances. This permit does not release the applicant from any Federal, State or Local authorizations.		
6.	Applicant shall not impact drainage in any way and will amend any soil disturbances or trail surface damage caused by the project activities within WisDOT owned property.		
7.	No large pieces of vegetative debris removed as part of the subject project will be left to remain on WisDOT property after the effective date of this permit.		
8.	All work shall be completed to the satisfaction of the Wisconsin Department of Transportation.		
9.	Applicant shall maintain (attached) certificate of general liability insurance naming the following as additional insured: Wisconsin Department of Transportation, Wisconsin Department of Natural Resources, Sauk County.

2. Brief Project Description discussing the proposed work (include methods, chemicals and / or equipment that will be used within the RR - ROW)

SpecPro Professional Services, LLC (SpecPro) is under contract with the US Army Environmental Command (Army) to install three (3) monitoring wells for monitoring groundwater contamination that has migrated from the Badger Army Ammunition Plant (Badger AAP). SpecPro has hired Cascade Drilling (licensed driller in Wisconsin) to install the monitoring wells to approximate depths of 119, 165 and 213 feet with an all-terrain vehicle (ATV) rotosonic drill rig with rubber tracks. The three wells will be completed above ground with steel locked casings and steel protector posts. Each well will be surrounded by a 2 x 2 foot concrete pad. No chemicals will be used to install the wells. All soil cuttings and trash will be removed from the work zone.

The wells will be located approximately 15 feet west of the Great Sauk State Trail's (Trail) asphalt edge (see attached map). Proposed center of the work site where the wells will be installed: Latitude - Longitude: N 43 19.3196 W 89 44.5706, WI State Plane NAD 83 South Feet: Y = 481,928 X = 2,036,931

The work zone will consist of an area approximately 75 feet long and 20 feet wide. The longer side of the work zone will be oriented parallel with the Trail. See attached map showing the work zone in relation to the Trail.

Below is a listing of the anticipated equipment/vehicles that will be driving down the Trail and working at the project location. See below picture of drilling setup. The drill rig and support vehicle will remain at the project location each night during the project. We anticipate driving down the Trail to access the work site from the north where the trail enters the former Badger AAP property.


- a. ATV rotosonic drill rig with rubber tracks

- d. Cascade Drilling pickup truck
- e. SpecPro pickup truck

After well installation, development and survey, dedicated groundwater sampling pumps will be installed in each new monitoring well. The new monitoring wells will be part of the Badger AAP groundwater sampling program. Semi-annual groundwater samples (April and September) will be laboratory analyzed for the six isomers of dinitrotoluene (DNT) and volatile organic compounds (VOCs).




