<u>Discussion of process to address long-term issues associated with Highway 12 corridor development</u>. - Short term sub-committee to address signage needs with the Department of Transportation.
- Stakeholders form and define the issues; Economic Development provided the platform and resources for discussion.
- Area of scope is from Ski-Hi to Lake Delton.
- Ensure that correct representative from the Department of Transportation is available as a resource.
- Consensus amongst stakeholders will give legislators what they need to support solutions at the state level. Dealing with a coordinated community of interests will allow for greater success.
