- Sauk County EM works continuously to keep Sauk County up to date with the newest guidelines and safest standards throughout the year. (Alert system, weather radios in schools, Nixle, etc.)

Departmental Program Summary:

Emergency management is the organization and management of resources and responsibilities for dealing with all natural (tornadoes, flood, earthquake, or hurricane) and man-made (active shooter, building collapse, fires, riots) emergencies—preparedness, response, and recovery—in order to reduce the harmful effects of all hazards, including disasters. Emergency management consists of five phases: prevention, mitigation, preparedness, response and recovery.

Changes / Accomplishments:

- Sauk County flood, rescues, shelters, sandbagging efforts, National Guard, Damage Assessments, Volunteer Management in the communities, successful EOC
- Sauk County Emergency Management has coordinated a disaster relief fund for flood victims within Sauk County. As of January 30, 2019, the fund is currently at \$305,000.
 The Long Term Recovery Committee (LTRC) is working to disperse those funds back to those affected by the flooding for unmet needs.
- Sauk County Emergency Management Trainings have trained almost 1500 people around the county in 2018 with various safety trainings. Work closely with county schools, businesses, hospitals, churches, etc. We continue to offer trainings to those that are in need of safety preparedness.

- Sponsored spring severe weather/tornado spotters training for over 70 people. Went to the National Weather Service (NWS) to interact with meteorologists and learning new technology to keep Sauk County current with the latest trends.
- Sponsored active shooter trainings with private and public partners.
- Helped with the Rural Safety Days Chemical Safety session.
- Held regular meetings with local emergency management representatives to keep them abreast of latest Emergency Management mandates from the State and Federal levels.
- Local Emergency Planning Committee remains in compliant
- Updated Internet site to deliver pertinent information via the web before, during and after events. Maintain social media networks via online, radio and television interviews and in the newspapers.
- Conducted full-scale exercise for Sauk County employees at Courthouse, West Square, and Reedsburg Human Services
- Sauk County Library Awareness Campaigns developed and implemented
- Attended Wisconsin Emergency Management Assn. Conference & Governor's Conference
- Completed several After Action Reviews of incidents that occurred in the County and surrounding counties.
