### PART ONE INTRODUCTION AND GENERAL INFORMATION

- 1.0 INTRODUCTION: This document constitutes a request for competitive, sealed proposals from qualified proposers to complete architectural and engineering services for the new Sauk County Parks Department Office and Community Building located at the White Mound Park, S7995 White Mound Drive, Hillpoint, WI 53937.
- 1.1 ORGANIZATION: This document, referred to as a Request for Proposals (RFP), has been divided into the following parts for the convenience of the contractor:

- 1.2 DEFINITIONS: For the purpose of this RFP the entity submitting the proposal will be referred to as proposer or vendor and Sauk County will be referred to as county.
- 1.3 BACKGROUND INFORMATION: Sauk County is one of 72 units of county government in the State of Wisconsin and is a municipal quasi corporation governed by the authority contained in Wis. Stat. ch. 59. County operations currently include a skilled nursing facility, a human services department, a law enforcement agency, a state circuit court system, a highway department, a tax administration and collection effort, and other government related functions.

#### 1.5 AMENDMENTS AND QUESTIONS:

- 1.5.1 Sauk County reserves the right to modify this RFP prior to the proposal due date. Such modifications will be issued by Amendment to all RFP holders.
- 1.5.2 If amendments are of such a nature as to require substantive changes in the scope of work or bid price, the bid due date may be postponed by such a time that will enable proposer to revise their bids. In such case, the amendment will include an announcement of the new proposal due date.
- 1.5.3 Interpretations or clarifications in response to questions received prior to the proposal due date may be issued by Addenda to all parties recorded as having received this RFP, if considered necessary by the County.
- 1.5.4 Questions received after September 29, 2016 may not be answered.

1.5.5 Only formal written responses to questions issued by letter or addenda are binding. Oral and other interpretations or clarifications are not binding.

#### 1.6 CONTRACT:

- 1.6.1 Sauk County intends to award a single contract to the proposal that is most responsive to this RFP, and presents the proposal that the county finds to be in the county's best interest based upon the factors identified herein. A contract proposed must be submitted as part of the proposer's submission in response to this RFP, and must also incorporate the terms of this RFP, including the County's standard terms and conditions included herein.
- 1.6.2 Contract type shall be a single, not to exceed sum contract, based upon time and materials that shall be billed to the county on a regular basis based upon the to date work completion. The not to exceed sum shall include any necessary reimbursables.

#### PART TWO SCOPE OF WORK

#### 2.0 OVERVIEW:

- 2.0.1 White Mound County Park is Sauk County's signature park, and includes a lake, beach, campground, equestrian and hiking trails, and a lovely setting among the hills of South Central Wisconsin. Sauk County's vision for White Mound Park includes enhancing its desirability and functionality as an attractive recreational destination for county residents and visitors for them to enjoy the many outdoor recreation opportunities the park has to offer. The County also wishes to provide potential for educational, cultural and environmental education activities yet unrealized.
- 2.0.2 The existing Sauk County Parks Department Office was built in 1988 and was constructed based on the needs of that time. The office has become too small and not customer friendly for the activities and operations today. Although regular maintenance has been completed on the existing log constructed facility, there are a number of issues with decay and insect issues with the logs. The Parks Department would like to construct a new multi-use building that consists of secured offices (approx. 1,200 ft²), storage and a multi-function community room (approx. 2,000 ft²) that can be utilized for weddings, family reunions, sporting events, educational activities and other functions complementary to the park. The building would include restrooms with shower facilities for the nearby beach and campground, as well as for the community room. These facilities would need to be accessible from the outside for campers or park visitors appropriate to a lake side facility. The community room should include kitchen facilities, a fire place and other amenities. Because of the remote location of the park, astronomy and star gazing have been suggested as possible attractive uses of the park and perhaps a use supported by this building.
- 2.0.3 In addition, Sauk County desires to construct a building that incorporates sustainable design into this project and applies LEED principles where desirable while not necessarily pursuing LEED certification. The primary goal of the sustainable component of this design should be to take less from the earth and give more to people, using the best of ancient building approaches in logical combination with the best of new technological advances. The objective is that this building will exist in its natural environment and compliment rather than detract from it. This building should promote clean water, air, beauty, and healthy human and biological communities. The proposer should use sustainable design to save money, waste fewer resources, while preserving the environment and creating an efficient, usable and attractive work space and community facility. The building should incorporate renewable energy sources including, but not limited to, solar, wind, geothermal or other concepts supportive of the overall intent of the design and where cost effective, maintainable and sustainable.

#### 2.1 REQUIREMENTS:

2.1.1. Development of architectural design for a new parks department office, community room, and rest room/shower facilities. The proposal must consider appropriate time to meet with parks director and to develop preliminary floor plan options, location, review options and develop final floor plan while considering optimizing location for both aesthetics,

operational requirements and the following sustainable design concepts; make appropriate use of the land; use water, energy, lumber, and other resources efficiently; enhance human health; create an efficient and functional design that is aesthetically pleasing and complements the natural setting; conserves plants, animals, endangered species, and natural habitats; protects agricultural, cultural, and archaeological resources; is pleasant to be in; is economical to build and operate; and utilizes alternative energy approaches where cost effective, appropriate and desirable.

2.1.2 The proposer is required to provide the following: Project vision articulation; site and resource analysis; project programming; contract documents including bid document preparation; schematic design; design development; construction oversight of the general contractor; building commissioning and close-out.

#### 2.2: DESIGN, BUDGET AND APPROVAL:

- 2.2.1. Proposer shall include civil, landscape, well, septic, structural, HVAC, electrical, plumbing, fire protection, interior and exterior architectural engineering.
- 2.2.2 Proposer shall provide services necessary to complete all required construction documents including approved state plans, engineering services, bid documents, project/construction oversight, project closeout and any other services the proposer anticipates will be needed by the county.
- 2.2.3. Proposer shall provide services to handle all necessary construction/project bidding processing with guidance from the Parks Director and other county staff.
- 2.2.4. Proposer shall have at least two (2) representatives involved with this project.
- 2.2.5 Proposer shall assure that all designs are in accordance with all appropriate building codes.
- 2.2.6. The proposer will provide appropriate time to meet with the Sauk County Highway & Parks Committee and make a presentation to the Sauk County Board of Supervisors.

#### 2.3: SCHEDULE

2.3.1 The work included in this request for proposal shall include a no later than date. The following is a tentative schedule of key dates, but proposer should provide a schedule that includes these significant dates along with other dates essential to the proposer's work that they intend to follow with regard to this project. It is intended that the proposer should work backward from an October 2017 occupancy date and present a realistic schedule to accomplish occupancy by that date.

October 12, 2016 - Committee Meeting – Committee selects a vendor.

October 18, 2016 - County Board Meeting – approves contract with vendor.

October 19, 2016 - Contract signed by county and delivered to vendor.

October 19, 2016 - Design development begins.

January 31, 2017 - Vendor provides final Architectural design.

February 08, 2017- Vendor provides presentation to Committee on final design.

February 10, 2017- Bid documents for construction are released.

March 06, 2017 - Construction proposal due date.

March 07, 2017 - Review bids certify lowest qualified bidder.

March 08, 2017 - Review bids with Highway & Parks Committee/select contractor.

March 21, 2017 - County Board approves the contract for construction.

April 01, 2017 - Construction starts.

October 31, 2017 - Building ready for occupancy.

#### 2.4 SUBMISSION REQUIREMENTS:

2.4.1 Fully review this Request for Proposal (RFP) in its entirety. This RFP in its entirety along with all other requested information must be returned as part of the proposal submittal. Failure to do so may be the basis for non-consideration of a proposal. In addition to the other guidance provided herein, the following are the minimum, required submittals:

Cover letter

Introduction to the firm and team

Explanation of approach, philosophy

Explanation of work to be performed

Project schedule (based on some dates provided)

Resumes of key personnel

List of green design "tools" that the team would use (and why they are appropriate)

Lists of subconsultants and their qualifications

Statement of qualifications

Compensation (broken down by phase) or fee structure. Time and materials with a not to exceed amount.

Sample projects and other relevant experience

References.

2.4.2. Cost. The county requires that the successful proposer submit a proposal that provides for a not to exceed amount that will be billed on a time and materials basis through the end of the contract. The proposer assumes the responsibility to complete the services contemplated within the not to exceed amount.

## PART THREE GENERAL REQUIREMENTS

#### STANDARD TERMS AND CONDITIONS (REQUESTS FOR PROPOSAL)

- 1.0 SPECIFICATIONS: The specifications in this request are the minimum acceptable. Sauk County shall be the sole judge or equivalency. Proposers are cautioned to avoid proposing alternates to the specifications which may result in rejection of their proposal.
- 2.0 DEVIATIONS AND EXCEPTIONS: Deviations and exceptions from terms, conditions, or specifications shall be described fully, on the contractor's letterhead, signed, and attached to the request. In the absence of such statement, the proposal shall be accepted as in strict compliance with all terms, conditions, and specifications and the contractors shall be held liable.
- 3.0 ACCEPTANCE-REJECTION: Sauk County reserves the right to accept or reject any or all proposals, to waive any technicality in any proposal submitted, and to accept any part of a proposal as deemed to be in the best interests of Sauk County.
  - 3.1 Proposals MUST be date stamped by the County Clerk, on or before the date and time that the proposal is due. Proposals dated and time stamped in another office will be rejected. Receipt of a proposal by the mail system does not constitute receipt of a proposal by the Administrator.
  - 3.2 Proposals shall be submitted on company letterhead and signed by an officer of the company. Mark sealed envelope "PARK OFFICE"
- 4.0 TAXES: Sauk County and its agencies are exempt from payment of all federal tax and Wisconsin state and local taxes on its purchases except Wisconsin excise tax on alcoholic beverages which is excepted by State Statutes.
- 5.0 ENTIRE AGREEMENT: These Standard Terms and Conditions shall apply to any contract or order awarded as a result of this request except where special requirements are stated elsewhere in the request; in such cases, the special requirements shall apply. Further, the written contract shall constitute the entire agreement and no other terms and conditions in any document, acceptance, or acknowledgment shall be effective or binding unless expressly agreed to in writing by the contracting authority, except that these Standard Terms and Conditions shall apply along with the proposal submission of the successful proposer.
- 6.0 APPLICABLE LAW: The vendor shall at all times comply with and observe all federal and state laws, local laws, ordinances, and regulations which are in effect during the period of this contract and which in any manner affect the work of its conduct. The Sauk County Circuit Court shall be the court of exclusive jurisdiction for any litigation between the parties arising out of the performance of this contract. This contract shall be interpreted in accordance with the laws of the State of Wisconsin. It is understood that requirements of Wis. Stat. § 59.52(29) do not apply to this solicitation as the contract awarded will not involve "public work" as defined by Wisconsin law.
- 7.0 ASSIGNMENT: No right or duty in whole or in part of the vendor under this contract may be assigned or delegated without the prior written consent of Sauk County.

- 8.0 SUBCONTRACTORS: If subcontractors are planned to be used, this should be clearly explained in the proposal. Sauk County reserves the right to reject any subcontractor. However, the vendor will be responsible for contract performance whether or not subcontractors are used.
- 9.0 ARBITRATION/APPEALS PROCESS: Notice of intent to protest and protests of any award made must be made in writing and filed with Sauk County Clerk, Sauk County West Square Building, 505 Broadway, Baraboo, Wisconsin 53913, within five (5) calendar days after discussion and recommendation of award. Sauk Co. Code ch. 33 and Wis. Stat. ch. 68 shall apply.
  - 9.1 Any dispute arising after award as to performance, quality and/or quantity shall be subject to arbitration as provided under Wis. Stat. ch. 788 except as provided in 9.2. Vendor agrees to join necessary parties to arbitration.
  - 9.2 Sauk County reserves the right to have claims, disputes, or other matters in question decided by litigation. If Sauk County waives its right to litigation, then the arbitration provisions shall apply.
- 10.0 NONDISCRIMINATION: In connection with the performance of work under this contract, the vendor agrees not to discriminate against any employee or applicant for employment because of age, race, religion, color, handicap, sex, physical condition, developmental disability as defined in s. 51.01(5), Wis. Stats., sexual orientation or national origin. This provision shall include, but not be limited to, the following: employment, upgrading, demotion or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship.
  - 10.1 Failure to comply with the conditions of this clause may result in the vendor becoming declared an "ineligible" contractor, termination of the contract, or withholding of payment.
- 11.0 SAFETY REQUIREMENTS: All materials, equipment, and supplies provided to Sauk County must comply fully with all safety requirements as set forth by the Wisconsin Administrative Code, Rules of the Industrial Commission on Safety, and all applicable OSHA Standards.
- 12.0 HOLD HARMLESS: Vendor agrees to indemnify, hold harmless, and defend Sauk County, its officers, agents and employees from any and all liability including claims, demands, losses, costs, expenses and damages of every kind arising out of or in connection with services provided pursuant to this contract where such liability is founded upon or grows out of acts or omissions of any agents or employees of the contractor.
- 13.0 INSURANCE RESPONSIBILITY: The vendor performing services for Sauk County shall comply with the insurance requirements contained herein.
  - 13.1 Provide own insurance, countersigned by an insurer licensed to do business in the State of Wisconsin, covering the period of the agreement/contract indicating that vendor is insured under professional liability insurance in an amount not less than minimum amounts reasonably necessary and sufficient within the profession.
  - 13.2 Provide insurance certificates indicating required coverage, countersigned by an insurer licensed to do business in Wisconsin, covering the period of the agreement/contract. The

insurance certificate is required to be presented prior to the issuance of the purchase order or before commencement of the contract.

- 14.0 CANCELLATION: Sauk County reserves the right to cancel any contract in whole or in part without penalty due to non-appropriation of funds, or for failure of the vendor to comply with the terms, conditions, and specifications of this contract.
- 15.0 AUDIT: During the term of the contract, the vendor shall, upon the request of the Sauk County Controller, make available at reasonable times and places, such information as may be required for the purpose of auditing submitted bills for the service provided under the contract.
- 16.0 INDEPENDENT CONTRACTOR STATUS: None of the officers, employees, or agents of the vendor are employees of Sauk County for any purpose, including but not limited to compensation, fringe benefits, or insurance coverage.
- 17.0 PUBLIC RECORDS ACCESS: It is the intention of the county to maintain an open and public process in the solicitation, submission, review, and approval of procurement activities.
  - 17.1 Proposal/proposal openings are public unless otherwise specified. Records may not be available for public inspection prior to issuance of the notice of intent to award or the award of the contract.
  - 17.2 Certain records of the vendor may become public records under the laws of the State of Wisconsin. Vendor agrees to assist Sauk County in complying with open records requests.
- 18.0 PROPRIETARY INFORMATION: Any restrictions on the use of data contained within a request, must be clearly stated in the proposal itself. Proprietary information submitted in response to a request will be handled in accordance with applicable Sauk County procurement regulations and the Wisconsin public records law. Proprietary restrictions normally are not accepted. However, when accepted, it is the Contractor's responsibility to defend the determination in the event of an appeal or litigation.
  - 18.1 Data contained in a proposal, all documentation provided therein, and innovations developed as a result of the contracted commodities or services cannot be copyrighted or patented. All data, documentation, and innovations become the property of the Sauk County.
  - 18.2 Any material submitted by the proposer in response to this request that the proposer considers confidential and proprietary information and which qualifies as a trade secret, as provided in Wis. Stat. § 19.36(5), or material which can be kept confidential under the Wisconsin public records law, must be identified. Proposal prices cannot be held confidential.
- 19.0 DISCLOSURE: If a public official (Wis. Stat. § 19.42), a member of the public official's immediate family, or any organization in which a public official or a member of the official's immediate family owns or controls a ten percent (10%) interest, is a party to this agreement, and if this agreement involves payment of more than three thousand dollars (\$3,000.00) within a twelve (12) month period, this contract is voidable by the county unless appropriate disclosure is made according to Wis. Stat. § 19.45(6), before signing the contract.

- 20.0 MATERIAL SAFETY DATA SHEET: If any item(s) on an order(s) resulting from this award(s) is a hazardous chemical, as defined under 29 CFR 1910.1200, provide one (1) copy of Material Safety Data Sheet for each item with the shipped container(s) and one (1) copy with the invoice(s).
- 21.0 TERMINATION FOR CONVENIENCE: Sauk County reserves the right to terminate this contract for convenience upon 60 days notice.
- 22.0 TERMINATION FOR DEFAULT: Sauk County reserves the right to terminate the contract for default if, after twenty days written notice to cure default, contractor fails to satisfactorily cure the default.

#### 1.0 EVALUATION PROCESS

- 1.1 The award of a contract resulting from this Request for Proposal shall be based upon the proposal that best meets the intention of the county with regard to this award as expressed in this RFP. The following review criteria will be evaluated by the review panel in recommending an award:
  - 1.1.1 Price and price related factors. In proposing the cost of the proposal, the vendor must identify a not to exceed figure for all work related to the project and include in its proposal an estimate of the work needed to complete the project.
  - 1.1.2 Innovative design. The county desires to build a multi-use building that will be an architecturally pleasing building, cost effective to own, operate and maintain, environmentally sustainable, and provide opportunities for the public to use a multifunctional community space for weddings, gatherings, classes or other uses.
  - 1.1.3. Reputation and reliability of the firm. The proposer should include three examples of recent, relevant work as well as references.
  - 1.1.4. Understanding of "green" architecture, method of working with a community as a client, architectural solutions to environmental problems, prior experience in incorporating sustainable energy systems (exampled include wind, solar and geothermal) in design projects.
- 1.2 Completeness of proposal. All requested information is included as noted.
- 1.3 Sauk County reserves the right to reject any and all proposals or to reject all proposals and release a new RFP.
