2012 Mission: To protect and serve the citizens and visitors of Sauk County with professional, responsible, and timely law enforcement through the combined efforts of Patrol, Investigative, Administration, Clerical and Security personnel.

Departmental Program Summary:

The Sauk County Sheriff's Office programs consist of the following primary statutory duties and services:

Courtroom Security

Patrol activities for crime detection and prevention

Response to citizen calls for assistance and complaint/conflict resolution

Traffic Enforcement

Accident crash investigations

Criminal investigations

Record and serve arrest warrants

Record and serve civil process papers

Maintain a County Jail & Huber facility

Maintain a telecommunication terminal for law enforcement, police, and fire used in Sauk County (with the exception of Wisconsin Dells and Reedsburg)

Provide water safety patrol and rescue services

In order to provide the statutory services required the Sauk County Sheriff's commands and oversees a law enforcement agency consisting of 141 full time positions and 18 part-time personnel. The duties and services are assigned to one of the following three divisions and are supervised by a Chief Deputy, a Captain and two Lieutenants.

Accomplishments:

Highway Safety Grants

- 1. The Sauk County Sheriff's Office received \$25,000.00 in the Click It grant for 2012. We utilized \$24,768.00 for 688 hours of overtime traffic enforcement.
- 2. The Sauk County Sheriff's Office received \$25,000.00 in the Speed Enforcement grant for 2012. We utilized \$3,164.13 toward MDC compatible equipment for our patrol motorcycles and \$20,016.00 for 556 hours of overtime traffic enforcement.
- 3. The Sauk County Sheriff's Office received \$25,000.00 in the Alcohol Enforcement grant for 2012. We utilized \$4,295.00 toward MDC compatible equipment for our patrol motorcycles and \$20,448.00 for 68 hours of overtime traffic enforcement.
- 4. The Sauk County Sheriff's Office received \$1,296.00 from the Ho-Chunk Nation to provide seatbelt enforcement in and around Ho-Chunk lands from May 31 June 3, 2012. We utilized this for 36 hours of overtime traffic enforcement.

Accomplishments/Programs 2012

Sauk County Emergency Response Team

The Sauk County Emergency Response Team responded to 4 calls in 2012, including 2 mutual aid requests for barricaded individuals in Adams County and in Columbia County. The 2 remaining call outs in Sauk County were to execute a drug search warrant and for a barricaded individual.

Requests for Flag Presentations were down in 2012, typical past 5 year average is closer to 3-5 per year. This can be attributed to other agencies forming Honor Guards (ex. Marquette County Sheriff and Wisconsin Dells/Lake Delton Police) that are participating in events previously staffed by Sauk County. Other events attended are typical of past years (1 line of duty/other agency and 1 previous SCSD employee funeral).

Jail Revenues

The Sheriff's Department received additional revenues of \$536,865.40 by renting out available jail beds.

Inmate Meals Served

The Jail Food Service provided 185,806 meals for 2012.

Major Cases in 2012:

Suspicious hanging death turned out to be cerebral anoxia.

Female arrested for multiple gas drive offs over a several month time period. Drive offs occurred in Columbia, Sauk, and Dane Counties.

Child reported missing from Canada was located safely with family members in the TWP of Baraboo.

Multiple burglaries at Cupids led to arrests. Suspects were targeting the synthetic marijuana.

Drug overdose death in the TWP of Baraboo.

Juvenile injured from an accidental discharge from a large caliber rifle in the TWP of Westfield.

Stabbing incident in the TWP of Spring Green.

Identified a suspect producing counterfeit cashier checks. Case turned over to F.B.I.

Arrested two subjects involved in over a dozen burglaries in the TWP of Spring Green.

Arrested subjects involved in a string of burglaries in the TWP of Baraboo and the TWP of Merrimac.

Investigated a subject who was married to two people at the same time and the neither spouse was aware of the other.

Drug overdose death on a sandbar along the Wisconsin River in the TWP of Spring Green.

Arrested subject involved in over a dozen burglaries in Sauk County as well as Monroe and LaCrosse Counties.

Investigated numerous paving scams in the spring and fall.

Charged an employee with "Theft Greater Than \$10,000" from her employer in the TWP of Franklin.

Investigated the fire of the Old North Freedom School which completely destroyed the structure.

Arrested two juveniles for burglary, auto theft, and other charges in the TWP of Spring Green. The juveniles were apprehended in the State of Iowa with a stolen vehicle.

Arrested a subject for embezzlement from the Steam and Gas Show.

Arrested a TWP of Fairfield man for reporting his identity was stolen and someone was obtaining fraudulent loans using his identity. Investigation revealed the reporting person was actually applying for and receiving the loans.

Arrested suspects from Richland County for a burglary in the TWP of Franklin. Property recovered in Illinois.

Investigated over 30 reports of Sexual Assaults.

Sheriff's Boat Patrol Program

The Sheriff is responsible for water safety patrol and rescue. The primary waterways in Sauk County include Lake Wisconsin, Lake Redstone, Dutch Hollow, Wisconsin and Baraboo River.

Team Structure:

The Task Force is a multi agency Task Force compromised of officers from several municipalities within Sauk County. The Sauk County Sheriff's Office has two members on the Task Force. At this time there is no data which provides total statistics for the Task Force. Statistics are kept by respective jurisdictions for their officers.

The following statistics are the efforts of the Sauk County Drug Detective's involvement on the Task Force.

- 18 controlled buys.
- 6 investigations centered on heroin.
- 4 investigations centered on prescription narcotics.
- 3 investigations centered on cocaine.
- 1 investigation centered on methamphetamine.
- 17 investigations centered on marijuana.
- 5 investigations centered on manufacturing marijuana.
- 66 drug related arrests.
- 39 search warrants.
