

# Sauk County Logo Design Contest

## Entry Information, Agreement, and Release Form

I, the artist, hereby enter into this agreement with Sauk County and submit an original design to the Sauk County Logo Design Contest subject to all of the following conditions:

1. This entry is an original drawing of my own creation and is not copied, manipulated or duplicated from previously published photographs, artwork, or electronic graphic images.
2. I am 16 years of age as of date of submission.
3. I understand that the sole prize awarded for this contest is \$500.00.
4. Sauk County is not liable for any damage to or for the loss of any entry submitted by an artist. Insuring the entry, if desired, is the responsibility of the artist.
5. The logo design may be copied or reproduced for any purpose by Sauk County. I understand that if my logo design is selected as the winner, I will relinquish all claims, rights (including moral rights and intellectual rights), and benefits related to the display, modification, reproduction, publication, distribution, use, and other exploitations of the work, other than the prize awarded to the winning entry.
6. I understand that if my design is selected as the winner, Sauk County may pursue trademark or copyright of the design, and I relinquish any and all trademark and copyright claims of the design, including if it is altered in any fashion.
7. Any and all reproductions or copies of the design logo made or authorized by Sauk County may, or may not, identify the artist at Sauk County's discretion.
8. In this agreement, Sauk County and the artist include their respective officers, employees, agents, directors, subcontractors' and contractors' assignees, partners, representatives, successors, heirs, or members.
9. I verify that no copyright infringements have been made by my design and acknowledge that I am liable for falsifying information.
10. I agree to indemnify, hold harmless, and defend Sauk County, its employees and agents, against any and all claims of any nature whatsoever, including, but not limited to, claims of copyright infringement, by any party whatsoever, arising out of or in any way related to the submission of the logo design entry in this competition.
