WHEREAS, the stress of family caregiving has been shown to impact a person's immune system for up to three years after their caregiving ends and increases their chances of developing a chronic illness themselves; and

WHEREAS, the need for caregivers is growing as persons with disabilities are living longer, and people over the age of 85 are the fastest growing segment of our population; and

WHEREAS, caregivers reflect family and community life at its best. They are among Sauk County's most important natural resources; and

WHEREAS, caregivers deserve our lasting support, gratitude, and respect;

# AUTHORIZING SAUK COUNTY SHERIFF'S DEPARTMENT TO ENTER INTO A CONTRACT AGREEMENT WITH CORRECTIONAL HEALTHCARE COMPANIES TO OVERSEE AND PROVIDE LICENSED HEALTHCARE SERVICES FOR THE JAIL INMATES EFFECTIVE JANUARY 1, 2012

WHEREAS, the Sauk County Sheriff's Department is charged with the responsibility for administering, managing, and supervising the health care delivery system of the Sauk County Jail under Department of Corrections Code 350.09; and,

WHEREAS, the Sauk County Sheriff's Department solicited bids from medical healthcare providers to provide all medical services in the Sauk County Jail; and,

WHEREAS, Sauk County has received competitive sealed bids for medical services in the Jail based on an average daily population of 130, and the public opening of bids took place on September 12, 2011, at the Sauk County Law Enforcement Center, and the lowest responsible bidder is Correctional Healthcare Companies; and,

WHEREAS, your Committee believes that it is in the best interest of Sauk County to enter into a contract for a stipulated sum of \$241,940.64 with Correctional Healthcare Companies for the medical services in the Sauk County Jail; and,

WHEREAS, Correctional Healthcare Companies will be able to provide physicians and registered nurse in the Jail and will:

- o Provide 24 hours/7 days per week telephone consultation regarding inmate medical needs (i.e. the need to access emergency services, ongoing and newly identified treatments, medications and/or special needs);
- o Provide up to 100 hours a week of nursing services in the Jail to provide medical care to include receiving screenings, health assessments, scheduled sick call and prescription deliver to inmates;
- o Provide expertise in health care provision for the specialized inmate population;
- O Provide insurance coverage to defend medical practice in any potential civil litigation against the County of Sauk and/or the Sauk County Sheriff's Department.

**NOW, THEREFORE, BE IT RESOLVED**, by the Sauk County Board of Supervisors, met in regular session, that the lowest responsible bidder of Correctional Healthcare Companies in the amount of \$241,940.64 is hereby accepted by Sauk County for medical services in the Jail and the Sauk County Sheriff is authorized to sign up to a two-year contract on behalf of Sauk County.

Petition # 4-2011 Proposed Resource Conservancy-35 Rezone by the Town of Excelsior, Joe Fish, Town Chair.

Public Hearing Scheduled for: August 23, 2011

#### 4. Request

A request was submitted by the Town of Excelsior to change the zoning of property from a Resource Conservancy-5 to a Resource Conservancy-35 Zoning District. The purpose or basis of the rezone request, as stated by the applicant, is to establish a land use zoning program that reflects the vision and objectives of the Town of Excelsior's Comprehensive Plan. The land to be affected by the proposed rezone is noted in Appendix A on a map entitled, "Proposed Excelsior RC-35 Rezone," dated August 23, 2011. Also, please see Appendix B for a copy of a Town ordinance adopting an amendment to the Town of Excelsior Comprehensive Plan and which recognizes Resource Conservancy-35 Zoning.

#### 2. History/Information

#### **Background Information**

March 31, 2009. The Town of Excelsior Town Board adopted the Town of Excelsior Comprehensive Plan. The following Land Use Goal excerpted from this plan pertains to the Town's rezone request:

"Plan, control and manage development that will continue to foster a sense of community, and that will preserve the country flavor of the Township while maintaining a balance among agriculture, natural resources, quality of life and development."

Early 2011. The Town of Excelsior convened a committee composed of town residents to discuss and recommend to the Town Board a zoning program that best reflects the vision, goals and objectives in the Town's Comprehensive Plan. Utilizing a qualified consensus process, the Committee decided and recommended that the Town adopt Exclusive Agricultural zoning. Sauk County Planning & Zoning staff provided periodic technical assistance to the Committee regarding the differences between zoning options for consideration by the Committee.

July 12, 2011. The Town of Excelsior Town Board amended the Town of Excelsior Comprehensive Plan to correct errors and clarify programs. The Plan was also amended to include objectives and policies that relate to the rezone request. Also on July 12, 2011, the Town Board recommended approval of the Resource Conservancy-35 Zoning District. Please see Appendix C for a copy of the Town Board minutes reflecting the approval of Resource Conservancy-35 Zoning District. The policies and objectives from the *Plan* that support the rezone are as follows:

LU-Objective-12 Manage the creation of new lots for residential development.

LU-Policy-12a Replace the Resource Conservancy – 5 Zoning District with the Resource Conservancy – 35 Zoning District which will serve as a transitional zoning to the Exclusive Agricultural Zoning District. The transition to Exclusive Agriculture will occur after an updated Exclusive Agricultural Zoning District has been certified by the Department of Agriculture, Trade and Consumer Protection (DATCP) to meet the requirements of Wisconsin Statutes Chapter 91 and which has been approved by the Sauk County Board of Supervisors. Following certification and approval, the town will file an application with Sauk County to apply Exclusive Agricultural Zoning to all areas zoned Resource Conservancy-35.

LU-Policy-12b. The Town of Excelsior will utilize the Sauk County Planned Unit Development Program and intends to follow minimum standards set forth in the Sauk County Zoning Ordinance with regard to density, lot size, and sighting requirements.

July 19, 2011. A complete rezone application was received by the Sauk County Conservation, Planning and Zoning Department.

#### 3. Summary

In summary, the Town of Excelsior Town Board commissioned a committee of town residents to recommend updates to the Town of Excelsior Comprehensive Plan and to consider a zoning program that reflects the goals, objectives and policies of this *Plan*. The Committee recommended to the Town of Excelsior Board the adoption of Exclusive Agricultural Zoning with Resource Conservancy-35 zoning to serve as an interim zoning district until such time that DATCP certifies an updated Exclusive Agricultural Zoning ordinance that meets the requirements of Wisconsin Statutes Chapter 91. The Town of Excelsior Town Board has subsequently approved a rezone of the Town from the Resource Conservancy-5 to the Resource Conservancy-35 Zoning District.

WHEREAS, the Emergency Management Buildings & Safety Administrator along with the Facility Manager obtained bids for these repairs to be completed and after reviewing these bids, the Property & Insurance Committee recommends it to be in the best interest of Sauk County to accept the bid from Trane Building Services to complete the repairs at a cost of \$61,895.00 plus optional cost of \$8,629 if needed,

NOW, THEREFORE, BE IT RESOLVED, by the Sauk County Board of Supervisors met in regular session, that the Emergency Management Buildings & Safety Administrator is hereby directed and authorized to contract with Trane Building Services to complete the Chiller maintenance at a cost of \$61,895.00 plus optional cost of \$8,629 if needed.
