# RESOLUTION AUTHORIZING THE USE OF AMERICAN RESCUE PLAN FUNDS FOR BROADBAND EXPANSION

#### Background:

The Coronavirus State and Local Fiscal Recovery Funds provide a substantial infusion of resources to help turn the tide on the pandemic, address its economic fallout, and lay the foundation for a strong and equitable recovery.

The Coronavirus State and Local Fiscal Recovery Funds provide substantial flexibility for each government to meet local needs—including support for households, small businesses, impacted industries, essential workers, and the communities hardest hit by the crisis. These funds can also be used to make necessary investments in water, sewer, and broadband infrastructure.

LaValle Telephone Cooperative ("LTC") is seeking grants from the Public Service Commission to expand broadband resources in Sauk County. LTC has proposed two broadband expansion projects:

1. Dutch Hollow & Northwest (attached hereto as Exhibit A)

2. Lime Ridge (attached hereto as Exhibit B)

The County would be contributing American Rescue Funds in an amount of \$150,000 for the Dutch Hollow project and \$200,000 for the Lime Ridge Project. LTC is also working with the local municipalities for contributions to the cost of the project.

Reedsburg Utility Commission ("RUC") is seeking grants from the Public Service Commission to expand broadband resources in Sauk County. RUC has proposed the two broadband expansion projects:

1. La Rue/Denzer (attached hereto as Exhibit C)

2. Witwen (attached hereto as Exhibit D)

The County would be contributing American Rescue Funds in an amount of \$175,000 for the La Rue/Denzer project and \$175,000 for the Witwen Project. RUC is also working with the local municipalities for contributions to the cost of the project.

The County shall also provide in-kind assistance to the Projects in the form of waived fees for permitting, zoning and easements (except any State mandated fees) necessary for the Projects.

NOW, THEREFORE, BE IT RESOLVED, that the County Administrator is hereby authorized to enter into contracts with LTC and RUC to commit Sauk County American Rescue Plan funds, as described above, to expand broadband access in Sauk County; and

**AND, BE IT FURTHER RESOLVED**, that the County shall only enter into the aforementioned agreements upon the award of grants from the PSC to LTC and RUC.

AND, BE IT FURTHER RESOLVED, that any easements over County property shall be signed by the County Clerk.

# RESOLUTION NO. 60 - 2021

#### RESOLUTION REDUCING THE COUNTY BOARD SIZE

Background: The Sauk County Board of Supervisors has thirty-one (31) Supervisors. In 2020, the Sauk County Board hired a County Administrator changing how the county is managed. With this change the County Board has less operational authority and is responsible for establishing policy. As such, a review has found the following:

- 1. Sauk County is the 25<sup>th</sup> largest county in the State of Wisconsin as determined by the 2010 census with 61,976 residents.
- 2. Sauk County has the 6th largest county board (tied with two others) with thirty-one (31) members.
- 3. As of the last decennium, the state-wide average representation per county district was approximately 3,500 residents per district. Sauk County's representation was established at 1,999 residents per district.

The current plan calls for 31 single-member County supervisory districts. Sauk County 2010 census population — 61,976. Sauk County supervisory district target — 1,999.

### Amending the Rules of the Sauk County Board (July 2021)

Rule VI. Procedure

N. Amendments/Changes to the Rules of the Sauk County Board of Supervisors during the current term shall be proposed and adopted pursuant to the following procedure:

- 1. Proposed amendments to these rules shall first be reviewed by the Executive & Legislative Committee (E&L).
- 2. If E&L recommends adoption, the proposed rule change shall be introduced to the Board at the subsequent Board meeting.
- 3. The proposed rule change shall be read under the "Reports" section of the agenda. Discussion will be allowed with the Supervisor proposing the rule change being allowed to speak for 5 minutes to the proposed rule change and actively respond to other Supervisors clarifying questions.
- 4. THE BOARD SHALL TAKE NO ACTION after the initial introduction of the proposed rule change.
- 5. E&L shall then reconsider the proposed rule change at its subsequent meeting and vote on formally proposing the rule change to the Board at its (the Board's) next meeting with a 2/3 vote of all members present required for adoption of the proposed rule change

# AUTHORIZING PARTICIPATION IN THE STATE OF WISCONSIN OFF-HIGHWAY MOTORCYCLE TRAIL GRANT PROGRAM

Background: Sauk County annually participates in maintaining, acquiring, insuring or developing lands for public motorized trail use. In doing so, these public motorized trails are eligible for grant funds through the Wisconsin Department of Natural Resources. The program funds 100% of the cost for the acquisition, development, insurance, and maintenance of public trails. Funding for the program comes from registration fees and a portion of tax on gasoline. Grant applications must be submitted by the local governing body to the DNR.

The Driftless Area Dual Sports Riders contacted the County, requesting assistance with a grant application for a one-two day special event to be held at the Sauk Prairie State Recreation Area in the next year. Under the concept of re-purposing as described in the Master Plan. Sauk County is facilitating the grant on behalf of the local OHM club by requesting funds to cover the cost of a one-two day special event for Off-Highway Motorcycle riders in the next year. Under the Master Plan guidelines the club requests to re-purpose up to 50% of the established biking, equestrian and public roads within the Sauk Prairie State Recreation Area for the event.

Costs are estimated to be about \$1,925 for this event. Sanctioning/Insurance: \$450; temporary sign posts (wood lath): \$50; temporary direction arrows: \$50; misc supplies: \$1,125 and LRE staff time \$250. Signs and supplies will be reused at future events. The Master Plan calls for scheduling according to the weather, so an exact date cannot be determined at this time. This grant would be used to reimburse the club for actual expenses incurred as well as return utilized trails to the same condition as before the event. The club will volunteer labor to administer, prepare, staff and clean-up after the event.

NOW, THEREFORE, BE IT RESOLVED, by the Sauk County Board of Supervisors, met in regular session, that the Parks Program Coordinator and Land Resources and Environment Director, under the direction of the Land Resources and Environment Committee, be authorized and directed to submit an application on behalf of the Driftless Area Dual Sports Riders to the State of Wisconsin Department of Natural Resources for any financial aid that may be available for a proposed event at the Sauk Prairie State Recreation Areas as well as submit reimbursement claims along with supporting documentation within proper timeframe of project completion dates; sign and submit documents, and take necessary action to undertake, direct and complete the approved project.

BE IT FURTHER RESOLVED, by the Sauk County Board of Supervisors, that the Land Resources and Environment Department Director is authorized to execute an Off-Highway Motorcycle Development and Maintenance Contract with the Driftless Area Dual Sports Riders.

Background: Dannie S. Miller owns property in the NE ¼, NE ¼, Section 4, T12N, R3E Town of Ironton, and have requested a map amendment (rezoning) of property legally described pursuant to petition 13-2021 from Exclusive Agriculture to Agriculture zoning. The intent of the map amendment (rezoning) being to allow for a wood fabrication business. This use would require subsequent approval of a conditional use permit.

Pursuant to Wis. Stat. §59.69(5) Sauk County has the authority to develop, adopt, and amend a zoning ordinance. At a public hearing held by the Land Resources and Environment (LRE) Committee on June, 29, 2021; the LRE Committee made findings pursuant to Sauk County Code of Ordinance §7.150(9) and recommended approval of the map amendment (rezoning).

Pursuant to Wis. Stat. §66.1001 Wisconsin Statutes, any program or action of a local governmental unit that affects land use shall be consistent with the comprehensive plan. The Sauk County Comprehensive Plan, adopted by the Sauk County Board of Supervisors in 2009, defines managing and focusing "on efficient land use patterns that promote redevelopment of under-utilized lands. It sets limits on outward growth, incorporates permanent land preservation techniques, and achieves livable communities." Upon evaluation of the request, the Land Resources and Environment Committee found that the rezone request to enable a wood fabrication business meets this provision of Sauk County's Comprehensive Plan.

#### AN ORDINANCE APPROVING A MAP AMENDMENT (REZONING) OF LANDS IN THE TOWN OF IRONTON FROM AN EXCLUSIVE AGRICULTURE TO AN AGRICULTURE DISTRICT FILED UPON LEVI C. BORNTRAGER, PROPERTY **OWNER**

Background: Levi C. Borntrager owns property in the NE 4, NW 4, Section 17, T12N, R3E Town of Ironton, and has requested a map amendment (rezoning) of property legally described pursuant to petition 14-2021 from Exclusive Agriculture to Agriculture zoning. The intent of the map amendment (rezoning) being to allow for a Landscaping Center business. This use would require subsequent approval of a conditional use permit.

Pursuant to Wis. Stat. §59.69(5) Sauk County has the authority to develop, adopt, and amend a zoning ordinance. At a public hearing held by the Land Resources and Environment (LRE) Committee on June, 29, 2021; the LRE Committee made findings pursuant to Sauk County Code of Ordinance §7.150(9) and recommended approval of the map amendment (rezoning).

Pursuant to Wis. Stat. §66.1001 Wisconsin Statutes, any program or action of a local governmental unit that affects land use shall be consistent with the comprehensive plan. The Sauk County Comprehensive Plan, adopted by the Sauk County Board of Supervisors in 2009, defines managing and focusing "on efficient land use patterns that promote redevelopment of under-utilized lands. It sets limits on outward growth, incorporates permanent land preservation techniques, and achieves livable communities." Upon evaluation of the request, the Land Resources and Environment Committee found that the rezone request to enable a wood fabrication business meets this provision of Sauk County's Comprehensive Plan.

# AUTHORIZING TO CONTRACT WITH PRO LIGHTNING PROTECTION TO REPLACE THE ROOF TOP LIGHTNING PROTECTION SYSTEM ON THE WEST SQUARE ADMINISTRATION BUILDING

Background: The West Square Administration (West Square) building is home to many of the county's departments. The facility has a rubber-ballasted roof that has come to the end of its expected life. It was determined during the installation of the new roof, that current lightning protection system does not meet the current lightning protection standards. The lightning protection system is original to the building dating back to the 1994-95 construction. Since the building's opening two leasees have added cellular arrays on top of the building. The arrays need to be properly tied into the buildings lighting protection ring. The replacement lightning protection system has been designed to meet the most current UL96A, LP115, and NFPA780 standards. Building Services has budgeted for the West Square roof replacement and associated work as a capital project. Proposals were requested from qualified lightning protection contractors. Two vendors responded with proposals. The Property Committee recommends the replacement of the West Square lightning protection system be awarded to PRO LIGHTINING PROTECTION. at cost of \$13,900.00.
