Amending the Rules of the Sauk County Board (September, 2021)

Rule VI. Procedure

N. Amendments/Changes to the Rules of the Sauk County Board of Supervisors during the current term shall be proposed and adopted pursuant to the following procedure:

- 1. Proposed amendments to these rules shall first be reviewed by the Executive & Legislative Committee (E&L). The proposed amendment rule change shall then be introduced to the Board at the subsequent Board meeting.
- 2. The proposed amendment rule change shall be read under the "Reports" section of the agenda. The sponsoring Supervisor may speak to the proposed rule change for up to 5 minutes. The Board shall take no action at this point. Supervisors may relay their comments on the proposed amendment rule change to the sponsoring Supervisor afterwards, ideally via email.
- 3. E&L shall then consider the proposed rule change at its subsequent meeting and vote on formally proposing the rule change to the Board at its (the Board's) next meeting with a 2/3 vote of all members present required for adoption of the proposed rule change.
- 3. E&L shall then consider the proposed original or revised amendment at its subsequent meeting and forward a recommendation to adopt or not adopt to the full Board. The full Board will consider the proposed or revised amendment at its next regular meeting, with a 2/3 vote of all members present required for adoption
- 4. NOTE: this rule change is only for proposed changes to the County Board Rules after the organizational meeting of the County Board and has no effect on the procedures for adopting Rules of Board at the organizational meeting.

RESOLUTION NO. <u>76</u> - 2021

AUTHORIZING PARTICIPATION IN THE COUNTY CONSERVATION AIDS GRANT PROGRAM

Background: The Wisconsin Department of Natural Resources (WDNR) has grant funding available through the County Conservation Aids (CCA) program, specifically for the improvement of fish and wildlife resources under Wis. Stat. § 23.09(12). The CCA program is administered as a cost-sharing program, meaning the grant covers up to 50% of total project costs. The Land Resources and Environment Department plans to use the 2022 grant funds towards a prairie restoration project at White Mound County Park.

BE IT FURTHER RESOLVED, that Sauk County will comply with all state and federal laws related to the County Conservation Aids programs and will obtain approval in writing from the WDNR before any change is made in the use of the project site.

RESOLUTION NO. 79 - 2021

AUTHORIZING THE PURCHASE OF EQUIPMENT AND SERVICES TO CONFIGURE THE VIDEO ARRAIGNMENT ROOM AT THE LAW ENFORCEMENT CENTER FOR VIRTUAL APPEARENCES

<u>Background</u>: In response to the ongoing Coronavirus pandemic, Sauk County is experiencing an increased demand for virtual access to a variety of court appearances. As a result of the increased demand for virtual court appearances Building Services, the Courts, MIS, and the Sheriff's departments applied for a Department of Justice Coronavirus Emergency Supplemental Funding grant. Sauk County was awarded funds from the Department of Justice Coronavirus Emergency Supplemental Funding grant and need to be spent by September 30th, 2021. This resolution seeks to approve the purchase of the necessary audio and video equipment, and related services from Lifeline Audio Video Technologies, to provide this capability in the arraignment room at the Law Enforcement Center with available grant funds to cover the costs. The initial quote indicates that the upgrade costs are not to exceed \$21,000.

The arraignment room will have the capabilities for inmates and lawyers to appear in a court of law anywhere that uses Zoom or similar technology. The upgrade will greatly reduce the need to transport the inmates, thus saving money from the Sheriff's department budget. The upgrades would implement technology similar to what is currently being used in the County Board room and Community room at the Law Enforcement Center.
