2. Ordinances MUST be on file with the County Clerk at least 2 weeks prior to the County Board Meeting.
3. CONTINUE to remit all Original resolutions, ordinances and attachments to the County Clerk, with fiscal note approved and initialed by Accounting Department in single side format only. IF ORIGINAL NOT AVAILABLE BY DUE DATE – PLEASE ADVISE COUNTY CLERK and (remit a copy of Resolution or ordinance).
4. Continue to provide changes of Ordinances to Corporation Counsel for their review as soon as possible.
5. Provide the County Clerk a copy of handouts/written communications by due date.
6. Reports and appearances - contact County Board Chair by due date.
7. Notify the County Board Chair and Administrator of all new committee appointments and re-appointments. (cc: County Clerk) by due date.
8. County Board agendas are mailed out on the Thursday prior to the meeting.
