Facilities Planning Report:

David Armstrong presented the monthly facilities report; additionally advising the McKinstry audit is finished and available. It is rather a large document; therefore; please contact him if interested in reading it. Several offices need the carpet replaced. Estimated bid from Nonn's Flooring to include installation ranged from \$ 3,800 to \$ 5,600. A phone call to Kerry Beghin, Controller for guidance of the Sauk County Financial Policy provided sufficient information that no other bids were needed as long as total cost did not exceed \$ 5,000. MOTIONS (Giese/Kolb) to replace carpet providing costs do not exceed \$ 5,000. Motion carried unanimously. Further discussion regarding tiling repairs/replacement and additional carpet replacement will be a possible project later in August. A final draft RFQ will be available at our June.

Dean's Report:

Dean Pleger updated on the following topics:

Commencement is Saturday May 19 th.

Summer Session begins one week after commencement with a smaller percentage of enrollments due to more online classes. (which cannot be counted towards enrollment percentage). Fall enrollment looks good. Bachelor of Arts degree moving forward.

Science Building update – estimated \$ 200,000 in planning costs; approximately 4.6 million total costs. We can't lose focus of this project and need to keep it moving with planning to begin with the 2013 budget and possibly completed in 2014-2015.

Preparing a document explaining timeline of residential facility as mentioned earlier the RFQ resolution was approved by both the City and County.

MOTION (Kolb/Lombard) to adjourn and set a special meeting for Wednesday, June 6 at 8:00 a.m. and the next regular meeting to June 21, 2012 at 8:00 a.m. both meetings to be held in the Executive Dining Room. Motion carried unanimously.
