Call to order and certification of compliance with Open Meeting Law at 9:05 A.M.

Canvassers reviewed the zero report tapes to verify all totals were zero at the beginning of the night on the tabulation equipment. Votes cast at the April 4, 2017 Spring Election were verified reviewing the highest number of votes cast is the same or less than the highest numbers of voters reporting on poll lists, and verifying that the number of ballots cast is the same or less than the highest number of voters on the poll lists. Inspectors' Statements and Incident Logs were also reviewed and canvass incidents and adjustments noted.
