Subcommittee Updates:

- 1. Court Management** – D. O'Rourke reports that there have been 254 total signups for the CANS program and 359 reminder texts sent thus far. The first batch of satisfaction surveys were just sent out so data will be reported when collected. The subcommittee approves adding T. Gruber and T Greene to the group for work on the community service collaboration.
- 2. Court Case Management/Data Collection** – S. Alexander reports there have been twelve referrals into programming; one from Reedsburg PD and the other eleven from the District Attorney's office. There has been one successfully completed intake and that individual is scheduled to start programming in August. The subcommittee decided to focus its research efforts on the topic of re-entry initiatives next.
- 3. System Mapping** – A. Kuhlmann reports no new information since the last meeting due to having a reschedule to the subcommittee's last meeting. The CJCC will be made aware of the location of the September Chief's Association meeting when it is determined.
- 4. Treatment Court** – J. Evenson reports that the planning process continues with an anticipated start date of January 1, 2016. There are three final decision points that the subcommittee is still working out the details of and will continue to report progress.
