- Amanda Hanson presented on ATC, SUDS, and Education Navigator.
  
- Met January 13<sup>th</sup> – Follow up on issues. Stepping up Module 3. Discussion about DPA's and how they can do it on everything except drunk driving. Statistics on DPA? DA's Office feels they use them when they need to.

- Judge – if it is taken through Legislative may cause more restrictions.
- Rick Spoentgen- Some drug charges say they have to offer DPA. Overdose aider – no charge – law expired.
- Discussion about JDS and DA’s Office working together on DPA program. Brent Miller advised Brown County DHS supervises DPA program. Possibly a TAD grant for funding. Amanda- it would restrict prior violent offenders from being in program.
