Steve presented a plan to the committee for expansion of broadband throughout Sauk County. The expansion of broadband would benefit rural areas currently receiving little or no service. Steve discussed the details of a request for Sauk County to guarantee the Midwestern Disaster Area Revenue Bond Financing.
