Chair Vedro called the meeting to order at 10:00 a.m. and compliance with the open meeting law was verified.

MOTION (Czuprynko/Kriegl) to adopt the amended agenda. Motion carried unanimously.

Resolution Authorizing a Contract with Intrado Life & Safety Systems for Maintenance of the 911 System:

MOTION (Czuprynko/Kriegl) to approve the resolution and forward to the December 17, 2019 County Board meeting for approval. Motion carried unanimously.

<u>Consideration of Resolution Amending Sauk Co. Code, Chapter 1, Supervisory District Plan, Changing the Supervisory District Boundary between District 4 and District 6 Resulting from City of Reedsburg Annexation:</u> MOTION (Czuprynko/Riek) to approve the resolution and forward to the December 17, 2019 County Board meeting for approval.

Consideration of Supervisor Gruber's Public Records Request Responses:

Kleczek Bolin provided the committee with and update.

MOTION (Czuprynko/Riek) to release the most recent Corporation Counsel performance appraisal within legal guidelines to the County Board and Media by the end of the day December 11, 2019; if the documents are not released by the deadline, then the County obtains outside counsel, specifically Natalie Bussan from Cross, Jenks, Mercer & Maffei.

Chair Vedro stated for the record that he has had long conversations collectively with the Administrative Coordinator and Corporation Counsel. Vedro also stated, that he not being unable to bridge the gap between the two was in favor of bringing this item to E&L as he didn't want to be responsible for making decisions of the committee.

MOTION (Czuprynko/) to provide the statutory notice to all department heads that their most recent performance appraisals may be released, dependent on the Corporation Counsel's latest opinion when the committee goes into closed session to discuss and determine if documents are to be released. Motion failed due to lack of a second.

Olson opined to the committee that it would be in everyone's best interest to move this discussion to a future closed session meeting.

MOTION (Vedro/Riek) to postpone this item. Motion carried unanimously.
