The meeting was called to order at 5:04 p.m. by Reinfeldt.

Reinfeldt asked for a motion to adopt the July 21st 2021 Nurse Family Partnership Community Advisory Board agenda. Motion by Scharfenberg, second by Warwick to adopt the agenda.

Reinfeldt asked for a motion to adopt the April 21st 2021 Nurse Family Partnership Community Advisory Board Minutes. Motion by Kirchstein, second by Goyett-Fuller to adopt the minutes.

Business Items for Discussion and/or Action:

- A. Bodette to welcome and introductions
 - 1. Welcome and Participant Introductions:
 - i. Announced new Deputy Director, Jennifer Weitzel, starting on August 9th.
 - ii. **Program Updates:** NFP continues to transition from phone visits to in person visits but continues to use a mix. This is reflected in quarterly data numbers. Total clients enrolled is 82. Graduations continue as normal with Betsy graduating the most right now. New referrals anticipated to be slow in the summer. Outreach planning discussed by each nurse. Missy getting NFP stickers made for pregnancy tests, Angie planning Popsicle Thank You to the clinics/OB and playgroups, Betsy planning to set up a table at the Sauk County Fair and Sauk Cow Chip Throw, Jackie reached out to all social workers in the three health systems. Planning for organized high school outreach in late summer/early fall as no referrals from high schools last year. Michelle shared

that all the NFP programs are meeting to discuss streaming add with local FOX47 station. Missy and her client were featured in an article in the Baraboo News Republic.

- iii. Grant Annual Report: The Family Foundations Grant compares 19 program measure statewide with other grant programs. Sauk County NFP has higher breastfeeding until 6 month rates compared to others. Challenges to overcome include how the grant measures a referral to a resource after a high depression screening or positive abuse assessment screening. If client refuses, it looks like the nurse didn't refer based on how they collect the data. Highlights include the average time from referral to enrollment is 43 days and our rate is 47% (goal of 50%). Sauk NFP did receive 10 less referrals overall this year than the previous year (85 vs. 95). Our number one referral source is the clinics and number two is WIC. Sauk NFP successfully maintained enrollments via telehealth through the pandemic. Reviewed updated outreach words to use with clients: flexible & personalized to you. Do not reference "impoverished" or poverty.

- v. Adult Treatment Court (ATC) Overview: Amanda Hanson. Amanda discussed various Justice & Diversion (JDS) programs that include Adult Treatment Court. Other programs also include Substance Use Diversion & Support (SUDS), Law Enforcement Assisted Diversion (LEAD), Education Navigator/GED Program. Have worked closely with NFP at various times over the years. Michelle represents Public Health in ATC weekly.
- vi. Plans for outreach for October Meeting—guest speaker from Periscope Project. Michelle discussed upcoming guest speaker for Periscope Project on October 20th Virtual Meeting. Planning to outreach to all local providers in or out of county. Angie to pass out flyers for Popsicle Thank You. Next grant budget cycles starts October 1st. Betsy discussed Reproductive Health Coalition and how to join if interested. Group prefers virtual meetings. Michelle going on leave late October until mid-January.
