## 7. Directors Monthly Report

## A. Future Planning and Goals

- i. Jennifer Weitzel discussed a grant opportunity for the WI Partnership Programs and asked the Board of Health if they would submit a letter of support. Jennifer Weitzel explained the PNCC benefits and the funding. Motion by Tom Dorner to send a letter of support, second by David Clemens. Motion carried.
- ii. Treemanisha Stewart stated the first Public Health newsletter went out to specific towns. The electronic version will be emailed to the Board of Health. The next newsletter will have another town added, the focus is on towns with lower broadband internet access. A Spanish newsletter will focus on the Hispanic communities along with Hispanic businesses. All the information included in the newsletter is also on the Sauk County Public Health website.
- iii. Environmental Health study suggests there is a higher rate of carbon monoxide among men who do work in a closed garage or shed.
- iv. Environmental Health Department did not receive the Lyme disease funding for tick drags but other funds will be used to compete the project.
- v. Treemanisha Stewart is working with the DNR for well water testing to test for PFAS to be completed in each of the 9 grids in Sauk County.
- vi. The Public Health annual retreat is scheduled for all day September 9<sup>th</sup> and the department will be closed for the day. Treemanisha Stewart will work with MIS to have the greeting changed on the main phone line in case of an urgent matter.
- vii. The Sauk County website in general is not user friendly and Treemanisha Stewart will be utilizing carryover funds to have a Public Health app created.
- viii. Treemanisha Stewart spoke about Sauk County being designated a silver status in silver level.
- ix. The poverty rate among biracial persons is doubled that of white or black persons. Even though we may or may not have funding Treemanisha Stewart will explore inequities in our communities not COVID related.
