The meeting was called to order at 5:01 p.m. by Reinfeldt.

Reinfeldt asked for a motion to adopt the August 17, 2022 Nurse Family Partnership Community Advisory Board agenda. Motion by Scharfenberg, second by Kirchstein to adopt the agenda.

Reinfeldt asked for a motion to adopt the May 18, 2022 Nurse Family Partnership Community Advisory Board Minutes. Motion by Meise, second by Bauer to adopt the minutes.

Business Items for Discussion and/or Action:

- A. Reinfeldt to welcome and introductions
 - 1. Welcome and Participant Introductions.
 - *i*. Program updates: Family Foundations Grant period ends on 9/30/22 and next cycle starts on 10/1/22. So far, Sauk NFP has served 158 families this past grant year and enrolled 82 new families during that time. There were 25 new referrals and 7 graduations in Quarter 2. 62% of referrals came from OB/Clinics and 11% from WIC. New outreach specialist starts in early October and will be introduced at the next meeting. Meise discussed her participation in the Wisconsin Maternal Death Review Team and plans to share any prevention ideas with the NFP CAB. Bauer shared updates on American Academy of Pediatrics Guidelines for Safe Sleep and Breastfeeding until age two. AAP urges parents to make sure the baby sleeps on a flat not inclined surface during sleep and strongly

discourages bedsharing. AAP identifies stigma, lack of support and workplace barriers as obstacles that hinder continued breastfeeding. WIC is also training all staff on breastfeeding.

ii. Discussed what is most useful from NFP CAB Meetings: partnerships, updates in other sectors, resource sharing like the Waisman Center. Would like to hear more on: client perspective story, comparative data from last year, are sectors working well together-make improvements as needed for referrals, Roe vs. Wade outcomes and effect on women's health access for clients. WIC is getting most referrals after 1st trimester and wondering why this could be. States they are now getting a list of possible clients from the HMO's each month to follow up on. WIC also reports lower rates of breastfeeding initiation. Lowest rates in the last 10 years, 90-80% initiation rate. Bauer would like to review purpose of CAB from National Service Office as this is a model element and required for NFP. Bauer discussed outreach baskets that go to referral sources to thank them for sending referrals. Reinfeldt to see if Madison College can sponsor them. Need 10-12 baskets. Also, discussed continuing with virtual CAB Meetings and can add a hybrid version for in person in Baraboo if enough interest. To discuss at next meeting.
