4. State Maternal Mortality Review Team: Angie discussed her role on the state team that reviews maternal deaths up to one year postpartum and shared the results of those efforts in reports. Angie assists in reviewing a certain number of cases every other month that can then lead to discussion on gaps in the system and ideas to prevent deaths.
5. Sauk County Response Team: Sara Jesse presented on response teams that are made up of local MS for anything substance use-related, drinking too much or an accidental or intentional overdose, you receive a follow-up visit. This is a collaboration between Public Health Sauk County, WisHope, and local EMS agencies. The team makes an in-home or in-facility visit in an attempt to streamline a connection to substance use disorder treatment, harm reduction and other needed services. There have been 123 referrals from 7/1/21-6/31/22.
