The Health Department Director is collaborating with the Building and Grounds director and Corporation Counsel and will bring the changes forward with the board.

- E. Motion by Miller second by Van Asten to approve the increase in 2-step TB testing to \$40.00. Motion carried unanimously.

- G. Warwick reported on Nurse Family Partnership. Travel plans are being made for the two public health nurses to travel to Colorado for training in December.
