- A. Joyce Smidl presented the Womens Infants and Childrens (WIC) Annual Program Report. Board members were provided a copy of the 2015 WIC Annual Report. Discussion followed.
- B. Discussion of travel in excess of 300 miles for one (1) Public Health Staff member to attend The Public Health Preparedness 2016 Summit in Dallas, Texas April 19 22, 2016. Motion, by Carlson to approve travel in excess of 300 miles for one (1) Public Health Staff member to attend The Public Health Preparedness 2016 Summit in Dallas, Texas April 19 22, 2016, second by Zobel. Motion carried.
- C. Bodendein reported on the Brace Grant. Every Boad of Health member received a copy of the packet that was handed out at the February 4, 2016 meeting. Discussion followed. It was identified that communication and education of citizens is essential in being prepared for a crisis.

- D. Discussion of Assembly Bill 544/ Senate Bill 432, the sale of public water systems to private companies. Bodedein will provide an advisory statement regarding the legislation at the next Board of Health meeting.
- E. Bodendein gave a report on the Zika virus. A press release was put out on Friday, February 5, 2016.
- F. Warwick gave an update on Nurse Family Partnership (NFP) programs. Handouts were provided. Case load continues to increase.
- G. Bodendein gave an update on Accreditation. The action plan has been completed. Final review by Health Department staff will be tomorrow, February 10, 2016. The final plan will be submitted on Thursday, February, 11, 2016. The department will have one year to meet the identified conditions on the measures that were not met at the site visit.
- H. Discussion on Community Health Improvement Plan (CHIP) and reviewed Goals and Action Plan. The Community a Health Improvement Plan next meeting is March 16, 2016. Bodendein will send out a reminder of the meeting date.
- I. Bodendein gave update on Environmental Health Program. The Environmental Health Consortium will remain together until Dec 31, 2016. As of January 01, 2017 Sauk County will withdraw from the Consortium, at that time and through the 2017 budget process the Sauk County Environmental Health department will look to go Full Agent Status, starting in January 1, 2017. Community meeting will be set to give operators an opportunity to be heard. The benefits of going full agent would be local consistent inspectors, local contact for facilities and annual inspections..
