The meeting was called to order at 5:04 p.m. by Reinfeldt.

Motion by Delong to adopt the May 27, 2015 NFP Community Board Minutes and July 22, 2015 NFP Community Board Agenda, second by Fordham. Motion carried unanimously.

- A. Reinfeldt to welcome and introductions
 - 1. Grant Update-Warwick
 - i. Discussed Family Foundations (FF)-expansion of current funding in Adams County to include Sauk, Juneau, and Dane County.
 - ii. Grant to start October 1, 2015.
 - iii. Sauk and Juneau County to hire an additional Nurse Home Visitor.
 - Discussed shared marketing/data person between Adams, Juneau and Sauk
 Counties. Position was offered this week as Adams Co has the FF funding now.
- B. Krantz gave NFP Information
 - 1. Elevator Speech
 - i. CAB member shared their examples of how to tell another community member about NFP in one sentence.
 - 2. ACE Update to be presented at meeting on 10/28/15
 - 3. NFP Model discussed.

- 6. Mission/Vision Statement presented to group. Due to time constraints, CAB is asked to look at what they created and will discuss at CAB meeting on 10/28/15.
- 7. How CAB can help Nurse Home Visitors (NHV)
 - Discussed concern that there are not enough referrals coming in but the number of NFP eligible clients has not changed based on the birth reports in Sauk County from January 1, 2015 to today. Data presented.
 - ii. Women Infant Children (WIC) referrals are down as well. This is where half of NFP referrals come from.
 - iii. Goeckermann and Delong suggest coming to nurses meetings.
 - iv. Krantz to present at Baraboo Medical Associates Nurses meeting on 8/28/15.
 - v. Discussed that women first present as pregnant in the clinic.
 - vi. Discussed need to get the word out and continue to promote this program as a reminder. Multiple contacts to one site are needed.
 - vii. Discussed "warm hand-off" from trusted person to NHV.
 - viii. Discussed possible NFP presentation to teachers in the high school.
 - ix. Discussed NFP outreach to ER physicians.
 - x. Krantz encouraged CAB members to provide the name of a good contact at places of outreach to save time.
 - xi. Discussed upcoming outreach: Baraboo Medical Associates Nurses Meeting, RAMC CME 9/1/15, St. Clare CME 12/3/15, and pending Baraboo Rotary Club.
 - xii. Discussed Touched Twice Clinic at RACA on 8/1/15.
 - xiii. Discussed putting NFP flyers in clinic packets for pregnant women for self-referral.
