 - Warwick expect to hear back on July 15th on whether or not Sauk County was going to receive 10 years of grant funding for NFP but the results were delayed.
 - ii. Grant references were called and Warwick is still waiting for a response. To keep CAB posted.
 - 2. Referral/Tri-County Referral Form
 - New Tri-County referral form discussed. Currently 6 pending referrals. Since 7/1/15-7/1/16 NFP has had 86 referrals. In 2016, 45 clients were served. Since 7/1/15, 670 NFP home visits were completed with a total of 953.33 hours. Current Caseload: 39.
 - ii. CAB requested data for ages of clients.
 - 3. Outreach Updates
 - i. Krantz updated CAB on recent Outreach: RAMC OB and Jail Nurses. Still waiting on contact from Probation and Parole.

- ii. Per Allen, Hope House to reach out to Krantz for NFP outreach with new staff.
- iii. Discussed if Medicaid could refer to NFP when people apply. Capital Consortium serves 7 counties and not all have NFP. Warwick to follow up on this and report at next CAB meeting.
