- **1.** The meeting was called to order at 5:30 p.m. by Donna Stehling. Certification of the open meeting law was noted.

- 8. Business Items for Discussion and/or Action:
  - A. Barb Walsh, Public Health nurse gave a fourteen slide Immunization Presentation. Discussion followed regarding best practices and ways to increase the outcome percentage for 2 year olds. Barb also handed out a flyer on "Vaccines: What you need to know."

- **B.** Cathy Warwick reported on the Nurse Family Partnership program. All the Nurses are maxed out and the new nurse is currently ramping up. Warwick also provided the monthly written report on the updates of the program.
- C. Tara Hayes gave an update for the accreditation process. We are currently working on the accreditation report that is due in June 2018. Tara Hayes also reported on her and Staci Dankert's visit to Forest County Potawatomi Tribal Health Department last week, as a mentor, for accreditation, for their department.
- D. Report of the Community Health Improvement Plan:
  - a. Tara Hayes reported on the PDO Grant. We have completed over 870 trainings and yesterday gave our initial Naloxone trainings at Ho-Chunk House of Wellness. We will also be providing Naloxone training to 18 inmates in the jail.
  - b. Tara Hayes reported on the Sauk County Partnership for Prevention and Recovery coalition. Their next meeting will be held on May 24, 2018, and will have a Recovery Coach as a guest speaker. They will also be working on their four short term actions for the coalition. Hayes encouraged the Board members to attend this meeting.
  - c. Tara Hayes reported on the Overdose Fatality Review Team. Their second meeting will be held on May 23, 2018.
  - d. Ken Carlson reported there was no new information on the Healthy Communities Designation. Ken will be working on it May 14 through the 17<sup>th</sup> and will share the criteria at the next Board of Health meeting.

- A. Tara Hayes reported on the Lyme Disease Poster contest with school aged children throughout Sauk County. Contest was to increase awareness of vectorborne diseases and to check for ticks and use repellents.
