Offered Interim Director to Cathy Warwick. Decided remaining status quo for a year would be best. Michelle Posewitz asked for input from the Board on length of recruitment. It was decided that a minimum four (4) week recruitment would be best to cast a wider net for this position. Discussion on changing the pay band to an appropriate pay band for Director and Deputy Director Positions.
  - B. Discussed Level II versus Level III Health Department in conjunction with Director recruitment process.
  - C. Reviewed the Mid Term Assessment goals with Board members. The Board approved to move forward with this process as written.
  - D. Discussed Budget Projections for 2020. The Board decided to do status quo for the next year, with the exception of possibly adding an additional Sanitarian to the Environmental Health Department.

- will be losing their dentist at the end of this summer, which may have an impact on increasing dental needs in Sauk County.
