

#### Suggestions or comments:

There was a question about "free meals" given to employees from "we don't get it." Free meals are not a contractual obligation, however were initiated by administration for an incentive. A free meal is offered if someone is called in with no advance notice or asked to stay with no notice and wouldn't have a chance to prepare a meal. As far as the kitchen staff? I don't know how it is possible to know who has paid for the meals, or who hasn't, unless someone is directly in charge of the meal purchases. If you have any questions about qualifying for the free meals, please ask your supervisor. There has been some concern expressed regarding the smoking area in the back by the kitchen. I will ask staff to make sure that the ashes aren't dropped on the ground in front of the delivery door to be tracked into the kitchen. Also that the employees don't sit on the crates directly in front of the door. I know these have been mentioned in the past, but ashes in the kitchen are not sanitary and the deliveries need to be made quickly and they do not need to be tracking ashes into the building. The other option is to move the smoking section further away from the entrance. If there are any other suggestions to avoid the ash being brought into the building they would be appreciated.
