Suggestion Box Answers

There was an unsigned question regarding the kitchen staff and the meals. Whether an employee is on the food plan or buys meal tickets would not be known to anyone but the employee. Meals are not a part of the contract for any department, except for and only in special circumstances. There are standard and past practices that are ongoing. Thank you for bringing this to my attention. If you wish to discuss it further, you could sign the concern and then I could address this with you or you could ask me directly.

There was a great suggestion made that the facility could provide paid inservice days for CNA's. These could be in the spring and fall to cover the required inservices. This could be a negotiated item with the new contract, and I will certainly add it to the issues. At this time, though the contract does not specify this, but negotiations are coming up and suggestions are appreciated by administration. You could also contact your union representatives.

There was a suggestion that the nominations for employee of the month include department heads since the voting and nominating are done by all staff. I would be interested in knowing other opinions on this if there are any, and will also mention this at department manager's meeting in June. If you have any comments, please relay them on to your supervisors or myself.
