Kurt Schultz reported on a Committee that has been started in Dane County to work on improving laws concerning eliminating the use of handheld devices while driving and helping law enforcement agencies abilities to enforce such laws.

Brad Byom reported on new signage that is being installed at the crosswalks on USH 12 in Lake Delton area.

Mark Schauf reported on proposed paving projects on 8<sup>th</sup> Street and STH 123 and the installation of new crosswalk/school crossing signage located on 8<sup>th</sup> Street at the Wood Street and Jefferson Street intersections.
