COORDINATING COMMITTEE

MISSION

WHO IS ELIGIBLE?

- Sauk County Residents.
- Families with a child.
- Families with multiple needs or services involved (special education, child welfare, juvenile justice, medical, mental health, chemical dependency, and others).
- Children who may be at risk for placement outside of the home.
- Families who can identify goals for change.
- Families who need a team approach to help meet their needs.
- Families who are willing and able to participate in a team process.

TEAM MEMBERS



Team members include the parent(s) and caregiver(s), the child, the FCF Service Coordinator, and individuals who are important and influential in family members' lives.

Examples of natural supports include neighbors, caregivers, religious leaders, relatives, and friends. Additional professional supports may include social workers, mental health or chemical dependency treatment providers, law enforcement, school personnel, family advocates, and others. Meetings are scheduled around the family's schedule in a way that the majority of team members are able to attend.

HOW DOES IT WORK?

- When a referral is made, FCF staff set up an **Introductory Meeting** with the family to explain the process and gather information. Together, the family and FCF staff make a decision about starting an FCF team. The family will be directed to other services if needed.
- During the **Assessment** stage, the Service Coordinator will utilize an assessment tool that includes information about family life domains to identify specific strengths and needs.
- In the **Planning** stage, the team brainstorms about how the family's needs may be addressed. The team develops a *Plan of Care*, which includes long- and short-term goals, tasks, and timelines based on the family's needs. Team members take responsibility for completing tasks. All team members commit to supporting the Plan of Care.
- Throughout the **Monitoring** stage, the team meets to follow up on the progress of the goals on the plan. The team reviews and updates the goals regularly to reflect the family's changing strengths and needs.
- To prepare for potential crisis situations, teams develop *Safety Plans* to help ensure the safety of the youth, family, and community.
- In the **Transition** stage, the team will support the family in maintaining progress made and in developing a purposeful plan out of FCF services. Skills learned and progress made will be celebrated! Community and natural supports will be identified that will continue to support the family in the future.



SERVICE PRINCIPLES

- Family and team member involvement is voluntary.
- Services are child and family-centered, strength-based and oriented to the least restrictive options.
- Decisions are reached by team agreement whenever possible. All members have input into the plan and take ownership of the plan.
- Teams meet regularly, not only during crisis situations.
- Teams work on a full range of life needs that could affect the child and family.
- Teams develop crisis and safety plans.
- Teams focus on reaching attainable goals and regularly measure progress.
- Teams celebrate success.
- Care is unconditional; services change if something is not working.
- Competent, trained Service Coordinators provide services.
- Teams meetings are places of trust. All discussions stay within the group. Confidentiality is emphasized and respected.
