The meeting was properly posted and all interested parties were notified.

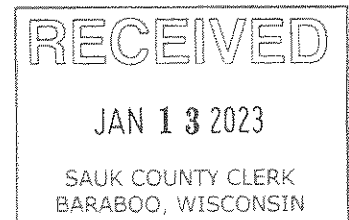

Captain Lange also updated the committee on the new camera systems for the Jail with SGTS out of Madison.

\$238,029.11. Bills discussed. Motion carried.


