#### 1. Call to Order and Certification of Open Meeting Law

#### 6. Review and Approve Expenses - Circuit Court

#### 8. Departmental Update and Approve Expenses - Child Support

Collections about the same as last year. On track with performance measures. There are 2 open positions & hoping to fill by next month. Final funding received from the state.

## 9. Departmental Update and Approve Expenses - Court Commissioner

Motion by Clemens, seconded by Schell to approve payment of the Court Commissioner expenses in the amounts of \$240.18 for 2023 and \$1,681.63 for 2024. Bills discussed. Motion carried.

#### 10. Departmental Update and Approve Expenses - Clerk of Court

January had 3 trials. 6 days with Spanish jury trial so should be able to recoup some of the interpreter fees by the state. Restitution collects about the same. Budget running on track.

Motion by Clemens, seconded by Scanlon to approve payment of the Clerk of Court expenses in the amounts of \$31,048.90 for 2023 and \$35,361.08 for 2024. Bills discussed. Motion carried.

# 11. <u>Departmental Update and Approve Expenses – District Attorney</u> Nothing to report.

#### 13. Departmental Update and Approve Expenses - Coroner

January has had a 25% increase in the number of deaths and February is up already for the month as well.

Motion by Schell, seconded by Carver to approve payment of the Coroner's expenses in the amount of \$4,936.48 for 2024. Bills discussed. Motion carried.

### 14. Departmental Update and Approve Expenses - Sheriff

Call for service for the month of January were 5439. Offender days 836. All the 2023 squads have now been received. Received the UTV last week.

Motion by Schell, seconded by Carver to approve payment of the Sheriff's expenses in the amounts of \$2,318.25 for 2023 and \$63,831.00, \$26,459.97 and \$340,682.96 for 2024. Bills discussed. Motion carried.

### 16. Discussion and Possible Action - Requesting ARPA Funds and Carryover

Discussion about additional ARPA funds needed to upgrade equipment in the squads. Original ARPA funds requested in 2022 only covered the cost of radios for the squads. Started adding new radios & equipment with the 2022 squads purchased. Will be requesting \$240,000 to equip the squads. Discussion on carryforward dollars on the vehicle replacements for 2023 that were not all received in 2023 in the amount of \$127,387.02 and to carryforward \$72,000 for the jail medical cost increase at \$6,000 per month.
