16. <u>Possible Resolution to Amend the 2024 Budget for Additional Allocation of Grant Funds to Combat Drug Trafficking within Sauk County.</u>

Discussion to purchase one-year premium subscription to Cellebrite software that enhances our ability to retrieve digital evidence from mobile devices and to purchase a mobile drug incinerator to dispose of drug evidence.
