## 9. Departmental Update and Approve Expenses - Child Support

Collections staying about where they were last year. Performance measures looking good. Budget report looks good.

Motion by Peper, seconded by Deitrich to approve payment of the Child Support Agency in the amount of \$1,660.84. Bills discussed. Motion carried.

#### 10. Departmental Update and Approve Expenses - Court Commissioner

Cases are on track. Budget looks on track and to be under budget for the year.

Numbers are down this year. About 10% below what it was last year. Cases are getting more complicated.

Calls for service were 6480. Offender days 956. Profit on GPS monitoring was \$14,025.90. K9 Jennings retired last week and new handler will be going to training in October. County Board Chairman asked to move forward with the crash responder safety week proclamation happening in November so next month that will be on the agenda.

Motion by Clemens, seconded by Peper to approve payment of the Sheriff's expenses in the amount of \$213,297.18. Bills discussed. Motion carried.
