7. Review and Approve Expenses - Circuit Court

8. Departmental Update and Approve Expenses – Register in Probate

Caseload and revenue are holding steady. Budget is looking that it will be underbudget for the year even with some overages in some expenses.

9. Departmental Update and Approve Expenses – Child Support

Collections down for November but hoping it will flush itself out in December. Agency is going to start charging for non 4D cases. Budget on track.

Case filings should end around what they were last year. Budget should be under budget for the year. Having some staffing concerns right now as people are out on FMLA, maternity leave in the near future and sick leave. Looking at getting an LTE to help with workload.

Motion by Deitrich, seconded by Peper to approve payment of the District Attorney expenses in the amount of \$1,292.55. Bills discussed. Motion carried.

13. Operations Update – Sauk County Animal Shelter

Monthly report posted in Granicus.

14. Departmental Update and Approve Expenses – Coroner

Down about 10% for cases, suicides are up. Standard invoices this month.

Motion by Clemens, seconded by Cross to approve payment of the Coroner's expenses in the amount of \$1,892.38. Bills discussed. Motion carried.

15. Departmental Update and Approve Expenses – Sheriff

Calls for service were 4691. Offender days 1022. Profit on GPS monitoring was \$16,377.86. Budget is looking like it will be under budget for the year.

Motion by Deitrich, seconded by Clemens to approve payment of the Sheriff's expenses in the amount of \$234,626.96. Bills discussed. Motion carried.


