Sauk Soil & Water Improvement Group (SSWIG)

There is a new group that is working to promote soil health and conservation practices among famers and landowners here in Sauk County. The Sauk Soil & Water Improvement Group or SSWIG is focused on improving the soil health and water quality of the area by minimizing runoff, increasing infiltration, and increasing the number of acres that incorporate comprehensive practices that will help to mitigate flooding events. They are currently working primarily in the Otter Creek, Honey Creek, and Narrows Creek - Baraboo River Watersheds.

If you are interested in learning more about SSWIG, then be sure to join them at their event, Farmers Helping Farmers with Conservation, on September 19. For more information on the event please see page 5.

SSWIG aims to increase knowledge among individuals including farmers, landowners and residents within the watersheds on the importance of soil health through on-farm field days, workshops, events, and on-farm research. Along with improving the soil health and water quality in the area, SSWIG is working to create a network and a community for farmers to share ideas and knowledge and support one another.

The committee is comprised of local farmers, Roger Bindl, Ron Bula, Darren Yanke, Ron Schoepp and Mel Zech. SSWIG is also working with the Sauk County Land Resources and Environment Department (LRE) and Extension Sauk County to organize events and record data from on-farm research trials.

You might have heard of SSWIG if you were at the Sauk County Fair this past July. They teamed up with

Sauk County LRE and Extension Sauk County to bring the "Soiled Your Undies" Challenge to Sauk County.

Members from SSWIG along with White Mound County Park buried some cotton undies in their fields, pastures, prairies, lawns, and woods to raise

awareness on soil health. For the challenge participants "planted" the undies at different sites with different farming practices or land use. After about a month the undies were "harvested" to see what was left over. Healthy soils are full of life and this challenge is one way to demonstrate healthy living soils. The organisms in the soil will actually break down the cotton (organic material) while it is in the soil. The less material left on the undies, the better!

Along with raising awareness on the importance of soil health by planting underwear, SSWIG has applied for a DATCP grant to help fund conservation practices such as cover crops and rotational grazing in the Honey Creek, Otter Creek, and Narrows-Baraboo River Watersheds for 2020.

Sign Up Now for Conservation Programs

Most conservation programs are open for signup anytime throughout the year and there is no time like the present! Staff can help you determine which program best meets your needs. Applications are scored as they are received and funding is applied to the highest-ranking projects until funding runs out. Here are some of the available programs to consider:

- **Technical and Financial Assistance** is available to landowners to install conservation practices to reduce soil erosion, protect water quality, and conserve the natural resources of Sauk County. If approved, landowners can receive up to 70% cost-sharing to install conservation practices including stream crossings, streambank stabilization, and grassed waterways.
- **Nutrient Management Program** assists landowners with the development of plans that address the proper application of fertilizers and animal waste to crop fields and pasture land. Eligible costs include soil sampling tests and plan development by a qualified consultant.
- **Baraboo River Watershed Regional Conservation Partnership Program (RCPP)** is a special pool of funding for the Baraboo River Watershed in Sauk and Juneau Counties. Technical and financial assistance is available to install conservation practices that prevent soil erosion and reduce agricultural runoff to ground and surface waters. Eligible practices include rotational grazing infrastructure, cover crops, and streambank stabilization.

New Name for Conservation, Planning and Zoning Department

A t the County Board meeting on Tuesday, May 21, the County Board of Supervisors discussed and acted upon an item that merged the Parks Department into the existing Conservation, Planning, and Zoning Department. Accompanying the merger was an approval by the Sauk County Board of Supervisors to change the name of the department to encompass all of the service areas provided through the department. The Conservation, Planning, and Zoning Department is now the Land Resources and Environment Department (LRE). The Land Resource and Environment Department encompasses three (3) service areas, to include Land Conservation, Planning and Zoning, and Parks and Recreation. We understand that it will take some time to get used to the new name, however, the types of service and level of service provided by the Department as well as how we provide such services will remain unchanged.



Wisconsin Forest Landowner Grant Program



The <u>Wisconsin Forest Landowner Grant Program</u> (WFLGP) was created to encourage private forest landowners to manage their lands in a manner that benefits the forest resources and the people of the state. WFLGP assists private landowners with protecting and enhancing their forested lands. The program allows qualified landowners to be reimbursed up to 50 percent of the eligible cost of eligible practices.

Eligibility:

Private landowners in Wisconsin are eligible for WFLGP funding if they own at least 10 contiguous acres of non-industrial private forest but not more than 500 acres within Wisconsin. Applicants must have a forest stewardship plan in place on their land or be applying to have one prepared through the WFLGP program. Landowners granted WFLGP funding can only be cost shared for noncommercial practices.

Eligible practices include: Management Plan development, Tree Planting, Tree Pruning, Invasive Species control work, Timber Stand Improvement work.

Application Process:

Applications can be submitted to the DNR at any time. WFLGP grants are awarded on four separate dates per state fiscal year. The bulk of the dollars are distributed on the August 1st award date. Application are awarded on a first-come/first-serve by priority basis. It is ideal to send a complete application well ahead of time. Landowners will receive an award letter from the WFLGP Coordinator indicating that eligible grant work may begin. Costs incurred prior to receiving an award letter are not eligible for WFLGP cost-sharing.



Assistance is Only a Phone Call Away!

Contact the LRE office at (608) 355-3245 if you are interested in any of the services listed:

- <u>Soil Health Assessment:</u> LRE staff are available to complete free soil health assessments on farms. Staff will determine how well your soil can absorb water, using compaction and infiltration tests. A slake test will also be completed to determine your soil's vulnerability to runoff and erosion.
- <u>Soil Sampling</u>: Soil samples will help you identify where lime applications should occur and is the basis for your nutrient management plan. Soil augers and soil sample bags are available at the LRE office.
- <u>Nutrient Management Plan Writing Assistance</u>: Our staff can help you write or update your nutrient management plan. If you have taken the NMFE class in the past, LRE staff can assist you with updating your nutrient management plan.
- <u>Manure Spreader Calibration</u>: If you spread manure and don't know your rate, staff from the LRE office can calibrate your spreader so you know what you're spreading.

Conservation Reserve Enhancement Program (CREP)

CREP pays landowners to install filter strips along waterways or to return continually flooded fields to wetlands while leaving the remainder of the adjacent land in agricultural production. Thousands of Wisconsin landowners have enrolled land in one of two enrollment options: 15-Year Agreement or Perpetual Easement. Currently, there are about 32 Easements and 117 Agreements enrolling 2,500+ acres into CREP in Sauk County.

What land is eligible for CREP?

Eligible land must be located in one of about 50 designated CREP counties, have a history of crop or pasture land, and be located within 150 feet of a ditch, stream, lake, or wetland. The typical CREP site consists of buffers ranging from 30 to 150 feet wide along a stream.

What are the eligible conservation practices?

There are many different conservation practice options through

the CREP program. The practice installed on a property depends on both site factors and desires of the landowner. Conservation practices include filter strips, riparian buffers, grassed waterways, wetland restorations, marginal pastureland habitat buffers, permanent introduced grasses, permanent native grasses, grass prairie ecosystem restorations, and established legumes and grass.
