PLEASE TAKE NOTICE, that the Land Resources and Environment Committee of the Sauk County Board of Supervisors will hold a public hearing on July 26, 2022, at 9:15 a.m. or as soon thereafter as the matter may be heard, in the County Board Room at the Sauk County West Square Building in the City of Baraboo to consider:

I. A. Petition 18-2022. A petition to consider amending conditions of approval for conditional use permit 6-2020 originally approved by the Sauk County Land Resources and Environment Committee on May 26, 2020 and documented in the Decision Letter addressed to Kingdom Storage, LLC pertaining to CUP 6-2020 pursuant to s. 7.040(4)(d) for mini-warehousing. Said conditional use is located in the Town of Sumpter, Sauk County.

Lands affected by the proposed rezone and conditional use are located in the E 1/2, SW ¼, Section 3, T10N, R6E, Town of Sumpter, and as further described in Petition 06-2020. Part of tax parcel identification number 034-0779-00000.

- B. Testimony of persons to appear at the public hearing; any person so desiring will be given a reasonable opportunity to express their opinions on the matter before the Committee.
- II. A. The purpose of the proposed conditional use amendment is to modify the following conditions of the conditional use permit 6-2020 as follows:
 - 1. Remove the requirement to plant seven deciduous trees between the facility and USH 12.
 - 2. Remove the requirement that a gravel driveway area be constructed on the west side of the storage building.
 - 3. Remove the requirement that an 'open style' perimeter fence be constructed around the facility.
 - 4. Add a second driveway entrance to East Avenue.
 - 5. Remove the row of trees between the church and the storage facility.
