Animal Shelter took in 31 dogs and adopted/reclaimed 31 dogs. They also took in 64 cats and adopted out/transferred out 34 in the month of March. The Animal Shelter also took in 3 rabbits, 1 mouse, 1 ferret and 4 Guinea pigs. They adopted/reclaimed/transferred 1 guinea pig and 1 parakeet. The Animal Shelter dealt with a total of 9 bite cases 5 dogs and 3 cats. They responded to 32 calls and impounded 13 dogs and 16 cats.
