Animal Shelter took in 28 dogs and adopted/reclaimed/transferred 15 dogs. They also took in 30 cats and adopted out/transferred out 35 in the month of January. They took in 6 hamsters and 2 rats. The Animal Shelter adopted out 2 rats, 2 Conures and 3 Hamsters. The Animal Shelter dealt with a total of 6 bite cases 1 cat and 5 dogs. They responded to 31 calls and impounded 15 dogs and 6 cats.


