Animal Shelter did not attend.

Animal Shelter took in 29 dogs and adopted/reclaimed/transferred 28 dogs. They also took in 90 cats and adopted out/transferred out 42 in the month of May. They took in 2 guinea pigs, 16 rabbits and 8 rats. The Animal Shelter adopted out 1 hamster. The Animal Shelter dealt with a total of 14 bite cases 2 cats, 1 bat and 11 dogs. They responded to 53 calls and impounded 14 dogs and 28 cats.


