11. Discussion of Sheriff's Budget

Sheriff explained the budget. He advised he increased the housing revenue by \$150,236 dollars for a total of 42.25 rentals. The 42.25 rentals was based on a 5 year average.

Kriegl made a motion to increase rentals to 50. Dietz supported the reasoning of increasing to 50 inmates. Kriegl and Dietz in favor, Reppen, Riek, and Wenzel against. Motion failed

Wenzel doesn't agree on moving it up by 16 from previous year. Riek stated he doesn't agree to increase to 50 based on the data supplied Reppen doesn't believe we should jump to 50 rentals.

Motion by Reppen to decrease Animal Shelter budget to 170,000. Seconded by Kriegl. 2 in favor 2 against. Dietz abstained. Motion failed

Motion by Wenzel to move budget forward, no second. Motion failed.
